

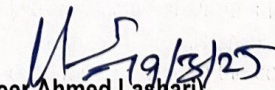
TENDER NOTICE

Photocopy of the bid security shall be attached with the technical bid. Bidder will also upload the complete scanned copy of their bid in EPADS on or before 18.04.2025 at 11:00A.M. Date and time mentioned in tender documents will be applicable. 01 hard copy of technical bid should be submitted in office Divisional Signal & Telecom Engineer, Pakistan Railways, Sukkur, however, technical bid/ documents uploaded on EPADS will be considered for technical evaluation.
