

The tender will be received and opened publicly in presence of bidders or their representatives who wish to attend on below mentioned date & time in the office of Director (Material Management), Canal Road, Abdullahpur FESCO Faisalabad.

In case of WAPDA/PEPCO/DISCOs registered/prequalified local manufacturers/suppliers/stockiest or unregistered international OEM firms, prototype Approval is not mandatory at the time of issuance of tender documents. However, if the lowest evaluated responsive bidder does not have valid prototype approval, the firm will get prototype approval from CE (S&S) NTDC Lahore after awarding of purchase order and before placement of inspection call. Sales Tax registration with FBR is also mandatory for local manufacturers/suppliers/ stockiest.
