Karachi Port Trust (KPT) invites Expression of Interest (EOI) from experienced and competent Consulting Firms, who are registered with Federal and Provincial Tax authorities and on Active Taxpayers List of the Federal Board of Revenue, to submit Expression of Interest (EOI) for Procurement of Consultancy Services, for Planning, Designing and Construction supervision of Auditorium Cum Convention Center at J-Bond Area, KPT Head Office Karachi by adopting Regulation-3(B) methods for selection of Consultants, Quality & Cost Based Selection of Procurement of Consultancy Services Regulations, 2010 of PPRA.

The work mainly comprises of:

- Detailed Design of Auditorium Cum Convention Center having facilities as stated in scope of services in the Prequalification Document.
- Preparation of BOQ's Tender documents/ drawing and conducting of procurement cycle for Construction of Auditorium Cum Convention Center.

- Having valid PEC/PCATP registration/license Certificate.
- The interested Firm must have experience regarding Design and Supervision of Complex Civil Structures.
- The interested Firm must have Technical Personnel for successful implementation of designing of Conventional Centers etc. and must possess firm's experience as stated in the Prequalification Documents.
- The interested firm should provide an undertaking on Legal Stamp paper stating that "The Bidder's company is not blacklisted by any Government entity in Pakistan for unsatisfactory pas performance, corrupt, fraudulent or any other unethical business practices and not involved in any kind of lawsuits with KPT either current or pending"
- Applicants fulfilling the Eligibility Criteria must write an undertaking signed by their officials on company letter head confirming fulfillment of criteria.
- The firms must possess Financial Soundness as stated under: In case of Companies, Firms, Individuals or Sole Proprietor, last three year Audited Financial Statements are to be provided showing minimum average turnover of Rs. 20 millions.

Guideline for submission of EOI

In order to qualify for the next stage, the Consulting Firm must meet the stated eligibility criteria. Interested Firms fulfilling the defined criteria are requested to submit their Expression of Interest by providing information that, they possess which reflects their required capability and expertise (including firm/company profiles, relevant experience, financial statement, description and experience of similar work, resume of appropriate personnel with appropriate skills, documents above mentioned and any other relevant information, etc.)

Expression of Interest at the firms meeting above listed criteria must be submitted online through E-PADS on or before 17-04-2025 by 1000 Hrs. and will be opened on the same day at 1030 Hrs., publically. Shortlisted firms who will qualify on the stated eligibility criteria will be contacted for submission of Technical and Financial Proposal.
