Chief Elect. Engineer (S&amp;C)-KPT. Authorized person of firm must show original CNIC and attached a copy of the same with authorization letter.</li> <li>Tender Documents fee @ Rs 5,000/- via cash, pay order or bank draft drawn in the name of Karachi Port Trust (KPT) to be deposited by the applicant in HBL KPT Head Office Branch. The Challan will be issued by M&amp;EE-II Deptt.</li> <li>Person who is to be authorized to collect the bid documents must show original CNIC and attached a copy of the same with authorization letter issued by Proprietor/Director/Partner of bidding company.</li> <li>Copy of Valid PEC certificate in Technical category EE-04,EE-05 with Financial category of C-6.</li> <li>Copy of Certificates of NTN, GST, SRB &amp; fresh copy of Active Tax payer List (ATL).</li> <li>Affidavit is to be submitted on Rs 100/- stamp paper mentioning therein that the firm has not been black listed by any Government / Semi Government / Autonomous / Semi Autonomous body.</li> </ol> <p>2. <b>BIDDING DOCUMENTS:</b> All the bidding documents (either downloaded or purchase physically) should be properly filled, signed, stamped and submitted along with the Tender and also copies of documents as mentioned above at Para1(d to f) are also to be submitted, without which the tender will not be accepted.</p> <p>3. <b>BIDDING PROCESS:</b> As per Clause 36 (b) of PPRA Rules-2004 (amended) for "Single Stage Two envelope procedures".
