Copy of NTN, GST, SST and fresh copy of Active Tax Payer List (ATL).</p> <p>(d). Copy of registration certificate with PEC in Technical Category ME-06 and Financial Category C-6.</p> <p>(e). Undertaking on Rs.100/- stamp paper to be submitted regarding not blacklisting of firm from KPT or any other Government organization / Agency.</p> <p>3.
