Terms of Reference

HEADHUNTING/FIRMS AND COMPANIES

- Pakistan Revenue Automation (Private) Limited (acronym PRAL). PRAL is a private limited Company registered under section 32 of the company's ordinance, 1984 (XLVII of 1984). PRAL is working with federal and provincial tax and revenue agencies to provide wide variety of tax and revenue collection automation solutions, since its incorporation in June, 1994. Online (ebids/proposals) are invited for the Pre-Qualification of Head-Hunting Firm/companies for recruitment of professionals in PRAL. The selected firm(s) will be engaged under a Master Service Agreement (MSA).
- 2. PRAL is desirous of acquiring a pool of professional headhunting firms/companies for recruiting candidates for various posts. The headhunting firms/companies should be well-reputed and experienced in proving head hunting services to different organizations. The headhunting firms/companies represents and warrants that they have the requisite expertise and adequate skills to provide the required headhunting services.
- 3. Interested headhunting firms/companies are required to furnish information for providing headhunting/executive search services in general management, securities market, law, accountancy, economics, finance, human resource, insurance, information technology, information security, media and risk management etc.
- 4. Selection or pre-qualification of headhunting firms/companies shall not bar the PRAL from using sources other than the selected/pre-qualified headhunting firms/companies.
- 5. The duration of pre-qualification shall be one year subject to satisfactory performance of the pre-qualified headhunting firms/companies and pre-qualification ground remain unchanged.
- 6. The headhunting firms/companies must be registered and must have valid NTN and GST number.
- 7. Bidders to strictly ensure that their bid documents are submitted on EPADs (online) before the closing time and date of the tender, else the system will not accept the bids after the closing time.
- 8. Questions about the bidding document can be made only in writing through EPADS or Email: at procurement@pral.com.pk and must be asked on or before COB March 05, 2025.
- 9. Although adequate thought has been given in the drafting of this document, errors such as typos may occur for which PRAL will not be responsible.
- 10. Firms/Companies cannot apply by forming a consortium (both local or International firms/Companies).
- 11. In case the bid opening day falls on a public holiday, the next working day shall be considered as the opening day for the same.
- 12. In case of any disruption/failure in submitting the bid on EPADS, PRAL shall not be held liable, since the EPADS is owned and operated by PPRA.

- 13. In case of any disruption observed on the day of bid opening due to any reason related to server/internet connectivity, the next working day shall be considered as the opening day for the same.
- 14. The firms / companies shall have required skills, expertise and team by which it can solely and exclusively supply all services/deliverables as specified in the bidding document without assigning it to any other individual/firm and hence shall not propose any "Joint Venture" in its bid. A company / firm offering services through joint venture with any other individual/firm shall be rejected.
- 15. The Procuring Agency, at its discretion, may extend "Deadline for Submission of Bids". In such case, all rights and obligations of the Procuring Agency and Bidders previously subject to the deadline shall thereafter be subject to the extended deadline.
- 16. The bidder should be a registered supplier on the e-Pak Acquisition & Disposal System (EPADS) to participate in the subject tender. To register electronically suppliers can visit https://eprocure.gov.pk/#/supplier/registration
- 17. All services shall be provided by the recruitment agency (hereinafter called "headhunting firm/companies") solely in connection with positions listed by the PRAL (the listings shall be provided in writing by the PRAL). Headhunting firms/companies shall not supply unsolicited resumes to PRAL without any prior written consent.
- 18. The pre-qualified headhunting firms/companies must provide PRAL with only those candidates who fully meet the specified job criteria and are deemed suitable for the position.
- 19. PRAL HR's representative shall coordinate with headhunting firms/companies during the period of assignment to ensure that the proposed time frame of the assignment is met. The headhunting firms/companies shall nominate a representative to liaise with the PRAL.
- 20. PRAL may also publish the job advertisement in newspapers, on the official website, and on official social media platforms. The advertisement should include contact details and the link to the job submission portal of the headhunting firms/companies.

- 21. PRAL will share the job description and specification in order to find closest match between the candidate and the job.
- 22. The headhunting firms/companies shall be responsible for accurately and fully disclosing all relevant information and CV of the concerning candidates to PRAL within (15) fifteen days after the closing date of advertisement. The required fields of information (database format) shall be shared with the headhunting firms/companies in advance.
- 23. Headhunting firms can quickly provide CVs of qualified candidates from their existing CV database or talent pool for urgent hiring needs.
- 24. The headhunting firms/companies shall send the list of total CVs received for the job post, the list of shortlisted CVs and the list of not shortlisted CVs to the PRAL with the reason. PRAL shall internally review and inform the best suited candidates meeting the departmental need.
- 25. The headhunting firms/companies shall obtain more specific and detailed information to facilitate selection decision. The referrals from last two employers (wherever applicable) will be done for each successfully selected candidate. The referrals must be conducted within the first 02-months/60 days of employment of the candidate.
- 26. Unless the parties agree otherwise in writing with respect to designated listed positions, the headhunting firms/companies will be paid for services only if PRAL hires/appoints the candidate referred by the headhunting firms/companies.
- 27. The headhunting firms/companies shall send an invoice against each appointed candidate and the payment will be made as per agreement.
- 28. In the event of a referral (from headhunting firms/companies if a candidate who is already known to PRAL by any means, shall promptly be notified to the agency in writing within 10 (Ten) working days.
- 29. In case the employment of the candidate placed by the headhunting firms/companies is terminated within ninety (90) days period from the date of joining or if the employee decides voluntary termination from the employment of the PRAL, within the probation period; the headhunting firms/companies shall provide a replacement candidate without additional cost only for that specified position within Ninety (90) days.
- 30. Either Party with one-month notice can invoke the termination of their agreement.
- 31. The agreement is the complete understanding of the parties, supersedes any prior oral or written representations or understandings, and can only be modified by written agreement of the parties.
- 32. Specific Information (for evaluation of expressions of interest)
 - i. Past relevant experience of providing head hunting /executive search services to:
 - Large, reputable and professional organization of similar nature including autonomous bodies, regulatory authorities, public sector, financial institutions, corporate sector etc.,

- Number of management cadre positions filled, level (senior, middle and lower management) for which full recruitment cycle has been completed during the last 5 years.
- ii. CVs/Resumes of qualified professional staff dedicated for this project on full time basis.
- iii. Brief methodology / steps to be followed while performing the desired role for the PRAL.
- iv. Name and brief detail of (if any) the specialized and licensed HRIS/Software support involved in the screening, shortlisting, and selection process of the candidates to be forwarded to PRAL for further evaluation.
- v. Financial Standing supported by a reference letter from the bank.

33. Client Feedback Assessment:

- i. PRAL will seek feedback from past/current clients of the headhunting firms/companies. The clients should include those from large, reputable, and professional organizations of a similar nature, including autonomous bodies, regulatory authorities, public sector financial institutions, and corporate sectors.
- ii. Feedback will be solicited regarding the headhunting firms/companies' performance, reliability, effectiveness in candidate selection, and overall satisfaction with the services provided.
- iii. Marks will be assigned based on the quality of feedback received.
- iv. Headhunting firms/companies must provide a list of at least six references with contact details from previous/present clients to facilitate this feedback process. In case of non-provision of reference details for feedback, no marks shall be awarded.
- v. Only clients for whom the headhunting services has been provided will be considered.
- 34. The headhunting firms/companies shall be shortlisted on the basis of above-mentioned required information and as per evaluation criteria prescribed in this document.
- 35. The HR Department will notify each applicant applying to pre-qualify whether or not it has been pre-qualified and will make available to any person directly involved in the pre- qualification process, upon request, the names of all applicants who have been pre-qualified.
- 36. Information relating to evaluation of proposals and recommendations concerning awards shall not be disclosed to the prospective Headhunting firms/companies who submitted the proposals or to other persons not officially concerned with the process, until the successful Headhunting firms/companies(s) have been notified that it has been awarded the contract.
- 37. Any efforts by the applicants to influence the PRAL, in the proposal evaluation, comparison or contract award process including false and misleading required information submitted with the application or in any clarification shall result in automatic disqualification.
- 38. Pre-qualified Headhunting firms/companies will have to sign a legal agreement initially for the period of one year. All the services shall be in accordance with the agreement signed between the parties' i.e., PRAL and the Headhunting firms/companies. Sample agreement is attached herewith as **Annex "B"**
- *39.* Only pre-qualified headhunting firms/companies shall be entitled to participate further in the procurement proceedings.
- 40. Role of PRAL and selected headhunting firms/companies is attached as **Annex "A"**
- 41. The headhunting firms/companies participating in the pre-qualification process may be

required to make a presentation on their organization profile, experience and methodology.

44. Minimum Pre-Qualification Criteria: The minimum pre-qualifying threshold is 70% or above marks out of 100, i.e., 70 marks or above, in the above-mentioned areas. All interested headhunting firms/companies obtaining 70% or above marks shall be considered as pre-qualified for the services. However, evaluation shall be carried out based on the provided evidence/copies of the headhunting service contracts in the proposal.

45. No marks shall be allotted if the required information mentioned above is not available in the proposal submitted by the bidders.

- 48. Only registered supplier/headhunting firms/companies who are on Active Taxpayers List (Income and Sales Tax) of FBR/respective revenue boards are only eligible to supply goods/provide services to the PRAL. Bids of all those who are not registered with the Federal Board of Revenue/Respective Revenue Boards for Income Tax and Sales Tax shall be rejected.
- 49. In case bidder (if selected) is not in ATL at the time of payment then the payment shall be stopped till he files his mandatory returns and appears on ATL of FBR OR whole of the tax involved or as applicable to supplies on the basis of gross value of supplies shall be deducted.
- 50. The headhunting firms/companies/bidders do not have the option of submitting their proposals/applications physically. Telegraphic and conditional proposals/applications will not be accepted.
 - 51. Applicant/Headhunting firms/companies must submit the undertaking as per format given on Annex "C" undertakings (on stamp paper of Rs.100), filing which the application shall be rejected.

ROLE OF PRAL AND SELECTED HEADHUNTING FIRMS/COMPANIES

- 1. Whenever PRAL has hiring requirements in the Management Cadre and does not opt for any direct hiring at its own, services of any of the selected/ pre-qualified headhunting firms/companies shall be used after procurement process.
- 2. All pre-qualified headhunting firms/companies shall be invited to bid against the hiring requirements. Most advantageous bidder/service provider shall be contacted and accordingly the PRAL will share the following:
 - a) Number, job title, location of the position.
 - b) Job Description and specific requirements of the position.
 - c) Approved copy of the draft advertisement as well as name of selected newspapers.
- 3. Most advantageous bidder/service provider i.e. headhunting firms/companies, shall ensure the following; but not limited to:
 - a) Analyze/scrutinize the information provided by PRAL and shall give consent for accepting the assignment.
 - b) The selected headhunting firms/companies shall coordinate with PRAL for the publication of advertisement.
 - c) All the applications with respect to the advertised positions shall be collected by the selected headhunting firms/companies that will perform initial review against the basic job specification, maintain a compressive database of all the applications, prepare list of all received applications containing the reasons for their shortlisting or rejection and provide the same to PRAL within 15 days after the closing date of advertisement.
 - d) By applying appropriate selection tools, the shortlisted applications shall be further scrutinized to find the closet match.
 - e) CVs of best suited five to seven shortlisted applicants shall be forwarded to PRAL along with related input and profiles uniformly structured as per agreed format.
 - f) The pre-qualified headhunting firms/companies must provide PRAL with only those candidates who fully meet the specified job criteria and are deemed suitable for the position
 - g) Headhunting firms/companies shall be responsible for accurately and fully disclosing all relevant information and CVs along with providing the following attested documents of shortlisted candidates:
 - Photograph.
 - All the educational documents/transcripts.
 - Entire experience and training certificates.
 - CNIC.
 - Domicile certificate (domicile information).
 - Last pay drawn certificate including all other benefits.
 - A written declaration in such form as specified inter-alia stating that, he/she has not been convicted by any court of law for any offence involving, moral turpitude, terminated or dismissed or removed or compulsorily retired by the Federal Government, Provincial Government, anybody corporate or institution as a result of

disciplinary action against her/ him. Moreover, that all documents and information submitted are genuine and correct in material particular.

- Since employment in PRAL is conditional upon the satisfactory results of the following, a written willingness/no objection certificate of the candidate shall be provided by the selected headhunting firms/companies for:
 - Pre-employment medical examination.
 - Providing all original degrees/ transcripts/ certificates/ CNIC at the time of joining (if selected) for verification from the concerned authorities.
 - Verification from previous employers and referees.
- h) PRAL will inform the selected headhunting firms/companies for finally accepted CVs and if required, may also ask for more CVs.
- The headhunting firms/companies shall be required to contact the candidates and inform them of their interview schedule i.e. date, time, venue; as provided by the PRAL via email. The PRAL may contact the candidates directly (if required). This exercise shall be done for panel interview and interview with the Management.
- j) The headhunting firms/companies shall share the candidate's availability status with the PRAL via email.
- k) No TA/DA shall be given to candidates for test/interview by PRAL.
- PRAL will communicate the name of the selected candidates to the concerned headhunting firms/companies; otherwise the process will be repeated till a suitable candidate is selected for the position.
- m) All further communication with the selected candidates pertaining to salary finalization and other related formalities like medical etc., may be made by PRAL directly or through the selected headhunting firms/companies.
- n) The selected headhunting firms/companies shall arrange verifications from the referees and minimum of last two employers with respect to the information mentioned in the application including job title, responsibilities, salary and benefits before PRAL make any written job offer to the selected candidate.
- o) A successful pre-employment medical fitness examination is mandatory for all the selected candidate.
- p) PRAL shall provide the headhunting firms/companies with the list of unsuccessful candidates and the regrets which shall be sent to each of them via email/post.
- q) On completion of the recruitment cycle of each position the selected headhunting firms/companies shall require to provide the following to PRAL:
 - Complete database of all the applicants along with summary sheet.
 - List of all applicants with reasons of their shortlisting or rejection.
 - Declaration on informing all the unsuccessful applicants about status of their applications along with the list containing name, address and date of communication.
 - Declaration of not referring the selected candidate to other competing employers for one year from the date of joining of candidate.

<u>The terms and conditions of the agreement and annexures may change with mutual</u> <u>consent at the time of signing.</u>

This agreement ("Agreement") is made on this _____day of ____2025

By and between

PAKISTAN REVENUE AUTOMATION PRIVATE LIMITED (PRAL) - herein referred to as the "Client") of the first part;

and

(herein referred

to as "Headhunting Firm/Company"), of the second part. The Parties hereto agree as under:-

PRAL and the Headhunting firm/company shall hereinafter be referred to as the "Parties" collectively and the "Party" individually and interchangeably.

Whereas;

- a) PRAL in order to ensure transparency and impartiality in the recruitment process is desirous of acquiring professional recruitment Headhunting firm/company ("Services") for the posts desired by the PRAL.
- **b**) The Headhunting firm/company is a well reputed and experienced candidate in similar industry.
- c) The Headhunting firm/company represents and warrants that it has the requisite expertise and adequate skills to provide the Services as required by the PRAL.
- **d**) PRAL has agreed to engage the Services of the Headhunting firm/company and the Headhunting firm/company has agreed to provide the same.

Now, therefore, upon the terms and subject to the conditions of this Agreement, it is hereby agreed by and between the Parties as under:

1. Duration

This Agreement will become effective on the ______and will remain in effect for a period of one year (the "Term") or until terminated in accordance with Clause 7 or 9. The termination of this Agreement will not;

(a) relieve either Party from any expense, liability or obligation or any remedy therefore which has accrued or attached prior to the date of such termination, nor

(b) cause either Party to lose, surrender or forfeit any rights or benefits which have accrued at the time of termination.

Prior to the expiration of the Term, this Agreement may be extended or modified by written mutual agreement between the Parties. When used in this Agreement, the phrase "the Term" shall refer to the entire duration of the Agreement.

2. Definition

In this Agreement, the following terms shall have the meanings assigned as under:

- a) "PRAL" means the Pakistan Revenue Automation Pvt. Limited.
- b) "Headhunting firm/Company" means _____
- c) "Services" means the recruitment headhunting search services to be provided by the Headhunting firm/company under this Agreement.
- d) "Department" means the HR Department of the PRAL.

3. Services

- a) The Headhunting search firm shall perform the Services under this Agreement as detailed in **Annexure-A**.
- b) The Headhunting firm/company shall perform and execute the Services at the times and in the manner as specified in <u>Annexure-A</u> to this Agreement with due care and skill in accordance with the best professional standards prevailing in similar industry to the satisfaction of the PRAL.
- c) The Headhunting firm/company recognizes and assures that any Services performed under this Agreement and work done shall be the exclusive property of the PRAL and the Headhunting firm/company shall have no right or claim to it.
- d) The Parties hereby agree that this Agreement does not in any manner restrict the PRAL from the appointment of any other Headhunting firm/company for similar purposes. The PRAL reserves the right of appointment concerning the subject matter of this Agreement and may appoint several Headhunting firm/company for the purpose of the Services stated herein.
- e) The Parties further agree that the PRAL will not appoint any other Headhunting firm/company for similar purposes during the time where certain positions are assigned to the Headhunting firm/company. However, the condition set forth in this sub-clause will remain in effect till the submission of final deliverable (summary profiles and resumes) for each position by Headhunting firm/company or a written notice of 10 working days by the PRAL revoking such assignment.

4. Responsibilities

a) Headhunting firm/company

The Headhunting firm/company shall:

- (i) ensure the effective performance and execution of Services detailed in Annexure-A.
- (ii) endeavor to effectively perform its obligations and ensure to satisfy the objective of the PRAL regarding the Services.
- (iii) make appropriate documentation available to the Department.

b) PRAL

The PRAL shall:

- (i) arrange for adequate and concise documentation in order to facilitate the Headhunting firm/company for the execution of Services to be rendered under this Agreement.
- (ii) facilitate the Headhunting firm/company regarding execution of the Services.
- (iii) provide adequate information necessary for the execution of the Services to be performed by the Headhunting firm/company.

- (iv) ensure that the terms of this Agreement are implemented as mutually agreed between the Parties.
- (v) ensure timely payments in accordance with the Agreement.

5. Payments

- a) The fee shall be as per bid submitted against the requirement.
- **b**) The amount quoted in the bid shall be the total fee and if declared as most advantageous bid, shall be paid to the Headhunting firm/company subject to the satisfactory performance of Services.
- c) All payments as agreed shall be less any Government taxes which the PRAL is required by law to deduct.
- d) The payments shall be made in Pak rupees through a mode as mutually agreed between the Parties.

6. **Proprietary Information/Confidentiality**

- a) During the course of the Agreement both Parties will share information of confidential and / or proprietary nature. Recipient agrees not to disclose any information to any third parties or to any of its employees except those employees who have a need to know the information to accomplish a stated task in accordance with the terms and conditions of this Agreement and such employees shall be made aware that the information is confidential and shall be under a written contractual restriction on nondisclosure and proper treatment of confidential information that is no less restrictive than the terms of this Agreement.
- b) Notwithstanding the foregoing, recipient may disclose the disclosing Party's information if in the opinion of its counsel, disclosure is required by law; provided, however, that recipient will use all reasonable efforts to notify disclosing Party of the obligation to make such disclosure in advance of the disclosure so that disclosing Party will have a reasonable opportunity to object to the disclosure and that recipient requests confidential treatment of the disclosed information. Recipient agrees that it shall treat the confidential information with the same degree of care it accords to its own confidential information of a similar nature; provided that in no event shall recipient exercise less than reasonable care to provide the confidential information.
- c) The treatment accorded by the foregoing clause shall be binding on both the Parties and shall remain in force for a period of five (5) years from the date of execution or completion/ termination of this Agreement.

7. Termination

- a) Either Party may terminate this Agreement if the other Party fails to remedy a breach of the terms of this Agreement within fifteen (15) days of a written notice to do so.
- **b**) The PRAL may terminate this Agreement if the Headhunting firm/company fails to provide the Services in accordance with this Agreement.
- c) The Headhunting firm/company may terminate this Agreement if the PRAL fails to make payments in accordance with this Agreement.

8. Other conditions

The Headhunting firm/company liability for loss or damages arising in relation to the services, as a result of breach of contract, tort (including negligence) or otherwise, is limited to an amount equal to the fees paid by the PRAL for the portion of the Headhunting firm/company services or work giving rise to the liability.

In any event and to the extent permitted by law, the Headhunting firm/company will not be liable for any indirect, incidental or consequential loss, damages or expenses (including loss of profits or revenue, business interruption, loss of data or failure to realize anticipated savings or benefits) arising in any way in relation to the Services.

9. Force Majeure

- a) The obligations of each of the Parties hereunder shall be suspended during the period and to the extent that such Party is prevented or hindered from complying therewith by "Force Majeure" (as hereinafter defined). In such event, the Party shall give notice of suspension as soon as reasonably possible to the other Party stating the date and extent of such suspension and the cause thereof. Any of the Parties whose obligations have been suspended as aforesaid shall resume the performance of such obligations as soon as reasonably possible after the removal of the cause and shall so notify the other Party.
- b) "Force Majeure" means any cause beyond the reasonable control of such Party including (in so far as beyond such control but without prejudice to the generality of the foregoing expression) strikes, lock-outs, labour disputes, natural catastrophe and compliance with any law or governmental order, rule, regulation or direction but solely restricted to laws, orders, rules, regulations, or directions of governmental agencies or bodies in Pakistan or of any other organization or PRAL or regulatory authority binding within Pakistan, provided that a lack of funds shall not constitute "Force Majeure".
- c) Nothing herein shall require the Parties concerned to settle strikes or labour disputes by acceding to demands deemed to be unreasonable by objectively evaluating the situation but subject to this, the Party concerned shall use its reasonable endeavors to remove, avoid and

/ or mitigate the effects of such circumstances.

- **d**) If the force majeure continues, or the carrying out of this Agreement is delayed, for a prolonged period or it becomes impossible to perform a material provision of this Agreement, either Party may terminate this Agreement by notice to the other Party.
- e) For the purpose of this clause, a prolonged period is one exceeding (30) days.

10. Dispute Resolution/Arbitration

- a) The Parties shall attempt to amicably resolve any and all disputes as to the interpretation of the Agreement or as to the performance of either Party hereunder.
- b) If the Parties cannot settle any dispute or difference within thirty (30) days after first conferring, then such dispute or difference shall be settled through arbitration each party shall appoint one arbitrator and the appointed arbitrators shall then appoint and umpire. The award of the arbitrators or in case of a dispute between the arbitrators, the umpire shall be final and binding. Either Party, before or during any arbitration, may apply to a court having jurisdiction for a temporary restraining order or preliminary injunction where such relief is necessary to protect its interest pending completion of the arbitration proceedings. Prior to initiation of arbitration or any other form of legal proceeding, the aggrieved Party will give the other Party written notice describing the claim and amount as to which it intends to initiate action.
- c) The arbitrators shall preferably be retired judges of High Courts of Pakistan. The arbitrators will have no authority to award or make any ruling, finding or award that does not conform to the terms and conditions of this Agreement.
- d) The place of arbitration shall be Islamabad and the language of the arbitration shall be English.

11. Notices

a) Any notice required to be provided pursuant to this Agreement shall be in writing and may be given by delivering the same by hand at, or by sending the same by prepaid first-class post, telex or facsimile to, the registered addresses of the Parties or such other address as the Parties may notify to each other. Any such notice given as aforesaid shall be deemed to have been given or received at the time of delivery (if delivered by hand), the first Working Day next following the day of sending (if sent by telex or facsimile) and the second Working Day next following the day it is sent (if sent by post). Without prejudice to the foregoing provisions of this Clause, if the Party to which a notice is given does not acknowledge the same by the end of the third Working Day next following the day of delivery by sending, the Party giving the notice shall communicate with the Party which has not so acknowledged and, if necessary, redeliver or re-send the notice.

b) Address for notices

For the purposes of this Clause, a Party may take the address and facsimile number of the other Party to be:

- (i) the address and number set out below; or
- (ii) where another address or number is notified by either of the Party to other Party, the last address of number so notified to it.

12. Relationship

- **b**) Disputes arising out of this Agreement are subject to the exclusive jurisdiction of the courts of Islamabad, to which the Parties irrevocably submit.

15. Stamp Duty

This Agreement shall be stamped in accordance with Stamp Act, 1899 by the Headhunting firm/company.

16. Annexure

The Annexure to this Agreement shall form an integral part of this Agreement and shall be interpreted accordingly.
