2. The contractors are required to submit their applications to undersigned on or before **10-02-2025** for issuance of tender documents along-with their complete credentials as shown at (Sr. No. 3). Contractors who are in Active Tax payers list (ATL) of FBR for income Tax & Sales Tax are eligible to submit their applications. Sales Tax & Punjab Sales Tax on Services (PST) may be applicable according to current rates.

3. For prequalification parties having experience, capability and resources may apply along with the following information and documents.


- Annex "A to G" as per MES Routine Instruction No. 604/21 for Pre-qualification of Contractors.
- Partnership deed, article of association or registration of firm certificate.
- An affidavit that the firm has never been black listed by any department.
- Certificate of payment of Income Tax & professional taxes (active tax payer showing status of 100%).
- Copy of registration with Pakistan Engineering Council in relevant field.
- Bank Statement of last two years.

4. Separate application alongwith supporting documents may be submitted for each work.

5. Those who fail to provide above mentioned documents shall be disqualified.

6. Earnest money @ 2% of contract amount need to be deposited in shape of CDR (Call Deposit Receipt) in favor of MD JBH Complex. No Tender will be deemed completed and valid unless it is accompanied with Earnest money. Earnest money will be returned to the un-successful tenderers.

7. M.D. – JBH Complex may reject all bids or proposal any time prior to the acceptance of bids or proposal.
8. Offer of contractors could be rejected on basis of their past performance.
9. Contractor already working with POFs need only furnish particulars of work in had inside & outside POFs with the addresses of clients.

The application shall be scrutinized and the tender documents will be issued to pre-qualified firms who have sufficient experience in the relevant field and satisfy other special conditions required for job and area upto 24-02-2025. Tender will be received at Bid Center C-04 building near Rabta Hall POFs Wah Cantt upto 10:30 Hrs on 13-03-2025 and will be opened at 1100 Hrs on the same date and venue.
