## REQUEST FOR EXPRESSIONS OF INTEREST

### Concept Development and Pre-Feasibility study for the establishment of the Professional Development National Academy

The Pakistan Engineering Council, with its Head Office located at Ataturk Avenue, G-5/2, Islamabad intends to establish the Professional Development National Academy (PDNA). For this purpose, the PEC has earmarked an area measuring 11.4 acres at DHA City, Karachi.

- i. Firms possessing similar experience, locally and internationally, of conducting similar exercises for educational institutions
- ii. Turnover of at least PKR 1 Billion per year in the last 3 completed financial years prior to the submission of this proposal.

Interested Firms are requested to submit:

- i. A company profile articulating their service offerings, value proposition, capabilities, organization structure, client portfolio and key projects.
- ii. Audited financial statements for the last 3 completed financial years.
- iii. Proof of income tax registration for the last 5 years.
- iv. At least 10 years of incorporated general project experience in conducting pre-feasibility/feasibility studies, concept development and strategy development exercise.
- v. Specific experience of relevance to the assignment including global and local pre-feasibility studies, concept development and strategic planning, and master planning of academic institutions.
- vi. A brief one-page conceptual framework for such an assignment be also attached.
