3. **Terms & Conditions**

- a. Bids may be submitted on the given address in ONE SEALED CONFIDENTIAL ENVELOP latest by **29 Jan 2025 (Wednesday) before 1030 hours**. No tender bid will be accepted after cut down date and time. The bids will be opened on the same day or otherwise.
- b. A bid bond, in the shape of a Bank Draft / Pay Order in the name of **Anti Narcotics Force HQs, Rawalpindi** amounting to Rs.2.5% (Refundable) of total cost should be submitted alongwith tender as security deposit.
- c. All the proposals and prices shall remain valid upto **30 June 2025**.
- d. All currency in the proposal shall be quoted in Pakistan Rupees (PKR) including all taxes.
- e. The bidder is hereby informed that the Government shall deduct taxes on prescribed rates under the tax laws of Pakistan, from all payments for services rendered by any vendor who signs a contract with the Government.
- f. The successful bidder will have to complete the given work as per our schedule, failing which, work order will be cancelled and earnest money will be forfeited in favour of Anti Narcotics Force HQs. The bidder will also be declared black listed. **An agreement / contract will be signed with the successful bidder on stamp paper mentioning details terms & conditions of the work.**
- g. Proposals shall be delivered by hand or courier so as to reach the address given below before closing date and time. **PROPOSAL RECEIVED BY FAX OR EMAIL SHALL NOT BE ACCEPTED.**
- h. HQ Anti Narcotics Force, Rawalpindi reserves the right to reject all bids or proposal at any time prior to the acceptance of a bid or proposal. The procuring agency shall upon request communicate to any supplier or contractor who submitted a bid or proposal, the ground for its rejection of all bids or proposals, but is not required to justify those grounds.
- i. HQ Anti Narcotics Force, Rawalpindi will announce the results of bid evaluation on same day in the form of a report giving justification for acceptance or rejection of bids at the time of awarding of procurement contract or otherwise.
- j. The bidder will submit his financial bid which will contain the rates of the work to be under taken.
- k. All bidders participating in the tender should be registered with PEC & FBR and must be included in active tax payer list maintained by FBR.
- l. All bidders will provide affidavit about non-black list on stamp paper.
- m. The participating bidders are requested to carry out the survey of the site of **Plot No. 126 & 127 Sector H-11/1 ANF Academy (Hostel & Academic Blocks) Islamabad** during office hours on any working day.
- n. Payment of work will be made through AGPR as running bills.
