1. The bids must be submitted through e-PADS as per PPRA procurement method 36(a).i.e. single stage one envelop procedure on or before **20.02.2025** by time: **11:00AM**. The Bids will be opened on the same day at **2:30 PM**. If opening date is declared as a Public Holiday by the Government or the office remains closed due to any reason, the tender will be opened on next working day at the same time.
2. The original bid security (refundable) of Rs. 30,000/- in the form of "Pay order"/"Demand Draft"/CDR in the favour of Pakistan Television Corporation Limited must be submitted to GM PTV News Centre before closing time of the tender. The bids without security or less than prescribed value will be rejected. Personal Cheque / Cash is not acceptable.
3. The hard copy of tender documents can be downloaded from PTV's Website(www.ptv.com.pk) or PPRA website(www.ppra.org.pk)
4. All prices must be in local currency, inclusive of all applicable taxes, such as GST, income tax, otherwise it will be assumed that the prices include all taxes. PTV will not be responsible for any cost due to changes in tax rate by the Government of Pakistan, at any time.
5. The firm must have registered office in Pakistan, Valid NTN and GST.
6. The proposal must be valid for 60 days from the date of opening.
