1. The bids must be submitted through e-PADS, as per PPRA procurement method 36A. On or before Date: **26.02.2025** (Wednesday) by time: **02 PM**. The Bids will be opened on the same day at time: **02:30 PM**. If the opening date is declared as a Public Holiday by the Government or the office remains closed due to any reason, the tender will open on next working day at the same time.
2. The original bid security (refundable) of Rs. **52,500** in the form of "Pay Order"/"Demand Draft"/"CDR" in favor of "Pakistan Television Corporation Limited" must be submitted to GM News, before the closing time of the tender. The bid without bid security or less than prescribed value will be rejected. Personal cheque/cash is not acceptable.
3. The hard copy of documents can be downloaded from PTV's website ([www.ptv.com.pk](http://www.ptv.com.pk)) or PPRA website ([www.ppra.org.pk](http://www.ppra.org.pk)).
4. All prices must be quoted in Local Currency, inclusive of all applicable taxes, such as GST, Income Tax and Custom & Excise Duties etc., otherwise, it will be assumed that the prices include all the taxes. PTV will not be responsible for any cost due to changes in tax rate by the Local or Provincial or Federal Government of Pakistan, at any time.
5. The firm must have a registered office in Pakistan, valid NTN and GST.
6. The proposal must be valid for a period of 60 days from the date of opening. In case of late delivery of equipment/consignment by the Supplier, a penalty @ 5% per month at the total bid value shall be applicable.
7. During the warranty period all expenses are to be borne by the supplier in case of the replacement of the unit/faulty parts.
8. No payment shall be made in advance. Payment shall be made after the delivery/inspection of the equipment and provision of the "ANNEXURE-C".
9. The bidder is required to mention complete specification and warranty of the quoted equipment.
