2. Bid must be submitted both electronically through EPADS and in manual form. However, manual submission without EPADS will not be accepted.
3. Sealed Tenders addressed to General Manager PTV-Corporation Limited Television Centre Peshawar should reach on or before 21-03-2025 . The word TENDER FOR UPS BATTERIES should be mentioned on the envelope will be opened on the same date at 03:30 PM.
4. Quoted prices must be in Pak Rupees and GST to be mentioned separately & clearly.
5. No advance payment shall be admissible.
6. Batteries are to be made available at PTV Peshawar for inspection by the inspection committee of PTV-Peshawar.
7. The batteries supplied by the successful bidder will be installed and commissioned by the supplier.
8. Payment will be made after installation, commissioning and issuance of satisfactory report from successful bidder.
9. Warranty period of 09 months to be mentioned in the Tender for satisfactory performance of batteries.
10. All tenders should be supported with the Bank draft equal to 5% of the offer as earnest money in favor of PTV Center Peshawar.
11. The earnest money of the second-lowest bidder will be retained until the issuance of the purchase order to the lowest bidder.
12. Conditional bids will not be accepted.
13. Income Tax will be deducted as per Government Rules.
14. The validity of quotations should not be less than 60 days.
15. The batteries shall be supplied within 30 days from the date of confirm purchase order to the successful bidder.
16. Copies of Annex C must be provided by the successful bidder with invoice.
17. The supplier shall be responsible for any damage done to the equipment or cabling of PTV during installation.
