

The bids must be submitted on e-PADs by **20th March, 2025, at 11:00 AM** which will be opened on the same date at **11:30 AM** through E-PADs. Original Bid security must be submitted to Controller Audit, Chairman, Senior Tender Committee, PTV HQrs Office, Constitution Avenue, F-5/1, Islamabad, or through STC Box placed at Reception of PTV-HQrs Office before the online submission deadline of the bid.

TERMS & CONDITIONS:

1. Bids must remain valid for a minimum of 60 days.
2. Prices should clearly specify the GST and any other applicable taxes; otherwise, they will be considered included in the quoted price.
3. All applicable government taxes will be deducted from the bill as per current regulations.
4. The bidding company must be an active filer and listed on the FBR's Active Taxpayer List (ATL).
5. Earnest money, in the form of a Bank Draft/Pay Order/CDR in favor of PTV, amounting to Rs. 100,000/-, must be submitted at the address mentioned above, which will be refundable.
6. Personal cheques will not be accepted.
7. The units must be delivered to the PTV HQrs. Office, Islamabad.
8. The Air-Conditioning units must carry at least a 1-year warranty period.
9. No extension in delivery time will be granted. Delayed deliveries may incur penalties @ 5% of the bid value.
10. Delivery of goods will be at the suppliers or bidder's risk and cost.
11. Incomplete or conditional quotations will be rejected.
12. Late submission of quotations will not be entertained.
13. An Affidavit on stamp paper declaring that firm/bidder is not defaulter/blacklisted by any government institution/PTVC.
14. No advance payments will be made. Payments will be processed upon delivery, inspection, and successful installation/operation of the units, and provision of "Annex-C."
15. Only PPRA e-PAD registered firms will be admissible, No physical bid will be entertained.
16. PTV reserves the right to reject any bid or proposal in accordance with Clause 33 of the PPRA Rules 2004.
