Pakistan Bait-ul-Mal (PBM), an organization of Federal Government was established under PBM Act 1991 to provide financial assistance to destitute and needy widows, orphans, invalid, infirm and such other persons, and thereby save them from hardships, sufferings and enable them to lead an honorable life in the society.

PBM intends to adopt CNIC based biometric verification system of electronic money transfer for its various present and future social safety net initiatives including Women Empowerment Centers (WEC), Schools for Rehabilitation of Child Labour (SRCL), Individual Financial Assistance (IFA), Special Friends Projects (SFP) and Orphan Widows Support Programme (OWSP) etc.
- 3. PBM invites e-bids for provision of BVS based services to PBM beneficiaries on single stage two envelope basis from eligible Financial Institutions (Scheduled Banks and Microfinance Banks approved by State Bank of Pakistan) duly registered with the Government, Income Tax and Sales Tax Departments and working as "Payment Agencies through Branchless Banking system; with the sub-partner agreements with Super Agents/ Agents and Sub Agents as defined in SBP's Frame work for Branchless Banking Agent Acquisition and Management, besides Biometric Verification System (BVS) ATM network" for providing the required BVS based services for PBM beneficiaries in a **transparent and convenient manner** as described in the criteria / instructions for the Financial Institutions / Bidders.
- 4. Biding documents, containing specification, detailed terms and conditions, procedure for submission of bids, method of fund transfer, bids security, bid validity, guarantee, acceptance and rejection of bids etc. are available at PPRA EPADS for registered bidders.
- 5. Encrypted Electronic Bids (both Technical and Financial) in accordance with PPRA rules and instructions given in the Standard Procurement Documents, shall be submitted at E-Pak Acquisition & Disposal System (www.eprocure.gov.pk), accompanied by call deposit receipt(s) / pay order(s) / Bank draft(s) as earnest money (refundable/ interest free), amounting to Rs. 3,000,000/- in favour of Pakistan Bait ul Mal, on or before 18th March, 2025 till 1100 hrs.
- 6. Technical bids will be opened on the same day (18th March, 2025) at 1130 hrs in Pakistan Bait ul Mal, Head Office, H-8/4, Islamabad in the presence of bidders or their representatives who chose to be present. Whereas, Financial Bids of Responsive Bidders will be opened later on for which date and time will be communicated through EPADS.
