Tenders are invited for two (02) years Service Level Agreement / Maintenance Contract, for Qty. 122 UPS(s) rating from 02 KVA to 08 KVA with parts and without batteries installed / working HQPAA, Airports / Locations of PAA, The firm must be included In Active Tax Payer List of FBR and registered with Directorate of General sales tax and Services sales tax in accordance with PPRA Rule No.36-b, The firm must have at least 03 years experience in repair, maintenance and servicing of UPS(s) with proper workshop facility alongwith qualified manpower (Engineer/Technician) at Karachi, Lahore and Islamabad for Preventive and Corrective maintenance of UPS(s).
