- The Bidder who is on Active Taxpayer's List (ATL) of FBR will be eligible to participate in the tender.
- Conditional, incomplete tender without 2% Earnest Money and Bidder(s) not fulfilling the above mentioned requirements shall be considered as non-responsive and shall stands disqualified i.e. Bidder(s).
- The rules quoted should be valid for a period of 30 days after the bid opening date. The successful Bidder shall give performance guarantee @ 10% of the contract amount.
