- 1) All bids should be accompanied with Rs. 25,000/= earnest money (refundable) in form of Pay Order/Demand Draft in the name of "General Manager/ Head (NESPAK) Peshawar Office".
- Sealed bid should be submitted on Company's Letter Head on or before the deadline of submission in the office of GM/Head (NESPAK) located at House No. 24, Sector B2, Phase -V, Hayatabad, Peshawar.
- 3) All applicable taxes including Federal and Provincial shall be deemed included in the quoted rates of all Bidders and shall subsequently be deducted from their invoices, at the time of payment.
- 4) Driver's food and accommodation shall be the obligation of concerned Bidder /Supplier. NESPAK shall not pay any extra charges, tips or commission to the drivers.
- 5) Driver's overtime for is to be admissible after 12 hours of duty. **Bidders must quote the overtime rates of drivers, separately in their bids.**
- 6) Vehicle shall remain under the use of NESPAK on weekends and holidays and the monthly rents shall be deemed inclusive in the quoted rates of Bidders.
- The duration of services shall be of One (1) Year which can be extended on satisfactory performance and mutual agreement of both parties.
- 8) The vehicle should be cleared from custom and law enforcing agencies during the period of Contract with registration documentation in the vehicle and registration number plate to be affixed to the vehicle.
- 9) Supplier shall be responsible for the cost of repairs, theft, maintenance, accidental damages, insurance and replacement of mobile oil, tires etc, of the vehicle and shall provide immediate replacement of vehicle in case of its breakdown.
- 10) The vehicle shall be complaint with applicable insurance, safety (as to cover any accident liability on passengers and drivers) or other motor vehicle requirements, as may be required by the client. NESPAK shall not bear any responsibility of Insurance. Vehicle shall have tracking facility.
- 11) Vehicle shall have good mechanical and body condition with working AC / Heater and Seat Belt. The vehicle should be equipped with necessary safety items, spare tire, mechanical jack and basic hand tools. The vehicle should have a well-maintained Log Book. Supplier shall provide timely oil/filter change and mechanical maintenance service as required and shall provide necessary documents to NESPA as and when required.
