**1. Invitation For Bids: -**

1.1. Trading Corporation of Pakistan Private Limited ('TCP') intends to purchase of Twenty-Four (24) Desktop Computers, Eighteen (18) Laptops, Twenty (20) Printers, Thirteen (13) Scanners, Four (4) Multifunction Printers, Ten (10) 8-Port Network Switches, Two (2) Cat-6 Copper Wire and Four (4) WiFi Devices at TCP's Principal Office, Karachi, Regional Offices Lahore and Southern Office, Multan.

1.2. The contract for supply of brand-new **Desktop Computers, Laptops, Printers, Scanners, Multifunction Printer and Computer Equipments (as defined in clause-2) of reputed brands**, as above shall be governed by the relevant rules & regulations, laid down by the Federal Government or concerned agency authority.

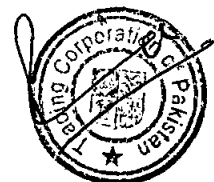

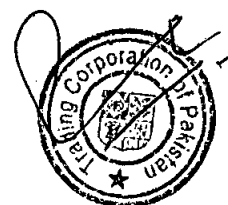

### **3 BASIS OF OFFERS/ PRICE**

- 3.1 The price shall be quoted in Pak Rupees only.
- 3.2 The quoted price shall be inclusive of all taxes, expenditure, including transportation, installation charges, warranty charges, and other charges, if any, whatsoever.
- 3.3 TCP shall only be responsible for the price on which the contract shall be awarded. Any claim, beyond this amount shall not be entertained, under any circumstances.
- 3.4 TCP reserves the right to accept or reject any or all offers wholly or partially as per PPR-2004.

### **4. ELIGIBILITY CRITERIA**

- 4.1 The bidder/firm must be registered with Income Tax, Sales Tax authorities and active on taxpayer lists
- 4.2 The Bidder must attach valid Distributorship/Dealership/Partnership certificate from the original manufacturer /principal authorizing the bidder to sell their products in Pakistan valid till 31<sup>st</sup> December 2024.
- 4.3 The bidder should certify the period / experience since their firm is involved in this business (which should not be less than five (5) years for eligibility) and the period of firm's association with the principal whose products are being offered.



- 4.4. The bidder should have accomplished at least two similar projects during the last two (2) years (Desktop Computers/Laptops/Printers/Scanners/Multifunction Machine supply and installations). The list of such projects be attached with name and contact numbers of the clients.
- 4.5 List of major clients in last two (2) years.
- 4.6 The bidder shall provide the free service and maintenance support of the Desktop computers, Laptops, Printers, Scanners and Computer Equipment in TCP's offices at Karachi, Lahore, Islamabad and Multan during one year warranty period.
- 4.7 The bidder(s) / firm(s) who had defaulted in its contract(s) awarded by TCP or any other Government entity are not eligible to participate in the tender. The bidder(s) / firm(s) who have not fulfilled their contractual obligation with TCP shall also not be eligible to participate in the Bid(s), unless they clear their dues alongwith penalties or fulfill their contractual obligations with TCP. The bidder/firm should not be blacklisted by TCP or & nbsp; any other Government entity are not eligible to participate. An affidavit to this effect shall be attached as per format at Annexure-I.

**5. BID EVALUATION CRITERIA**

- 5.1 Lowest responsive Bidder shall be awarded the contract.
- 5.2 TCP can ask for any details or information in respect of the offer submitted by the bidder, under provision of Public Procurement Rules, 2004. However, the original bid shall be treated for the evaluation purpose.

**6. VALIDITY:**

Offers should be valid up to 45 days, w.e.f. opening of bids.

**7. BID SECURITY / PERFORMANCE GUARANTEE:**

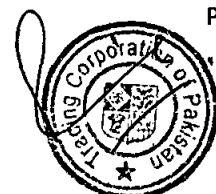
- 7.1 Bid Security word Rs.50,000 in the shape of a Demand Draft or Pay Order in Pak Rupees to be submitted to TCP before the opening of tender. The Bidders will submit a soft copy of Bid Security online on E-PADS system otherwise the bid(s) will be declared as non-responsive. Bid Security shall be forfeited if the bidder fails to sign the contract within seven (7) days of issuance of letter for award of contract.
- 7.2 Bid Security of the unsuccessful Bidder(s), including those Bid(s) which are not accepted for any reason, will be returned after award of tender to the successful Bidder(s).
- 7.3 Successful Bidder(s) shall be required to submit a Performance Guarantee within 7 days of issuance of award letter, equivalent to five percent (5%) of the quoted amount in the shape of a Demand Draft or Pay Order in Pak Rupees in favour of Trading Corporation of Pakistan (Pvt) limited, which will be returned after successful completion of the support warranty period, upon the satisfactory working of Desktop Computers, Printers, Scanners and computer equipment, including other services, in accordance with Tender Terms & Conditions and settlement of any/all claims. No claim shall lie against the Buyer in respect of interest on Performance Guarantee regardless of the time of its release.

**8. FORFEITURE OF BID BOND/PERFORMANCE GUARANTEE:**

- 8.1 The performance guarantee shall be forfeited if the bidder(s) fails to accept the award letter or fails to supply the goods within the specified period as per contracted terms and conditions.
- 8.2 Commits any breach of contract or fails to fulfill any terms or conditions of the contract.

**9. SUBMISSION OF BIDS:**

- 9.1 Interested firm(s) registered with Income Tax, Sales Tax authorities and active on tax payer lists, may submit their bids/offers alongwith required bid money on the basis of single stage one envelope procedure on PPRA, e-Procurement EPADS system upto 1000 hours on 28-11-2024. Bids will be received only from those firm(s)/bidders(s) who registered with PPRA Procurement on EPADS System. Bids received through fax, email, cable, courier or any other means except as prescribed above shall not be considered.



9.2 All bids must be submitted through EPADS as per prescribed proforma given in Annexure-II, III, IV, V, VI VII, VIII and XI.

**10. DOCUMENTS CONSTITUTING CONTRACT:**

The IFB (Invitation for Bids), the Terms & Conditions of Tender, Bid/offer submitted by the bidder and the Letter of acceptance Issued by the TCP shall constitute the Contract between the Buyer and the Seller.

**11. DELIVERY / INSTALLATION SCHEDULE:**

- 11.1 The supply of the equipments shall be positively completed within **15days or earlier**, after award of the contract.
- 11.2 The bidder shall be responsible for the smooth installation / configuration of Desktop Computers, Laptops, Printers, Scanners and Computer Equipment, according to the entire satisfaction of the TCP.
- 11.3 In case of a delay in supply/installation due to any untoward situation of the City or any situation/calamity confirmed same shall be brought into the notice of General Manager (IT), with sufficient proof immediately, well before the last due date.

**12. AFTER SALE SERVICE AND ASSISTANCE:**

- 12.1 The bidder shall provide the free service and warranty of the Desktop Computers, Laptops, Printers, Scanners and Computer Equipment for one year.
- 12.2 In the case more than three (3) working days are required for the repair of Desktop computers, Laptops, Printers, Scanners and Computer Equipment with parts, the supplier will provide a backup unit before commencement of repairs.
- 12.3 TCP can call the vendor for assistance at TCP's premises any time during office hours. The bidder shall be responsible to respond within 2-3 hours, upon receipt of intimation from TCP.

**13. PAYMENT:**

- 13.1 The payment shall be processed by TCP, after successful completion of installation and its satisfactory working, as per required terms & conditions within thirty days.
- 13.2 The seller shall submit the following documents to process the payment: -
  - 13.2.1 Seller's Invoice.
  - 13.2.2 Warranty Certificate to be issued on Stamp Paper, alongwith signed copy of document, as per Contract.
  - 13.2.3 Copy of Sales Tax Certificate.
  - 13.2.4 Copy of Income Tax Certificate / NTN Certificate.

**14. CANCELLATION OF CONTRACT:**

If the Seller fails to provide and deliver the items, as per specifications and within the specified period, the Buyer shall be entitled at his option to cancel the contract and recover the damages besides forfeiture of Performance Guarantee. The Buyer shall not be liable to any risks and costs whatsoever in consequence of such cancellation of the contract.

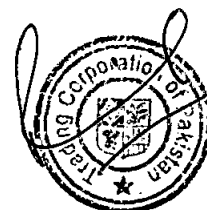
**15. ARBITRATION:**

Any difference or dispute or liability of whatsoever nature arising out of the contract or in any way relating to the contract or to its construction or fulfillment should be settled as far as possible, amicably between the Buyer and Seller. Should the parties fail to come to an amicable settlement the same shall be referred to the Chairman TCP for final decision. The decision of Chairman TCP shall be final and binding on both the parties i.e. Seller & TCP.
