Pakistan Airports Authority (PAA) invites proposals from registered companies / firms having sound relevant experience and having valid registration with SECP, FBR, EOBI & ESSI for SLA for provisioning of Telephone Operators at Pakistan Airports Authority (PAA) for New Gwadar International Airport (NGIAP), Gwadar for a period of three (03) years (extendable for a further period of six (06) months subject to satisfactory performance and mutual consent).
