CORRIGENDUM

2. It is to inform all concerned that following amendments in the tender terms and conditions are made:

- i) Under Clause-24(b)(i) the words "75% Payment" have been replaced with the words "95% Payment".
- ii) Under Clause-24(b)(ii) the words "Balance 25% Payment" have been replaced with the words "Balance 5% Payment".

3. All other terms and conditions shall remain unchanged.
