Karachi Shipyard & Engineering Works (KS&EW), a Ship Building & Repairing Yard intends to conclude a Rate Running Contract for hiring of Hydro-Blasting Services for above water, water level & ship bottom through complete Robotic cutting edge technology system onboard vessels/Ships Docked for Repair/Maintenance. The RRC will be initially concluded for a period of one (01) year and extendable upto period of Three (03) years.

Bids/Proposals are, therefore, invited in sealed envelope (Technical / Commercial) on Two stage bidding method from the sub-contractors (having experience of marine vessel repair work), registered with Income Tax and Sales Tax Departments. The technical proposal will be scrutinized / evaluated keeping in view the technical prequalification criteria attached with tender documents. The commercial offers will be opened in presence of only technically qualified bidder on the date intimated by KS&EW.
