- 4. An AFFIDAVIT (on Rs. 300/- stamp paper) that firm / company has not been blacklisted / defaulter and not involved in any kind of litigation whatsoever, with PAA or any other Government /Autonomous body should be submitted alongwith the bids.
- 5. Bid security amounting to Rs. **300,000/-** in shape of pay order/ Bank draft of any schedule bank drawn in favour of **Pakistan Airports Authority AlIAP Lahore** should be submitted along with the bids in sealed envelope and copy of the same must be attached on EPADS online portal.
