
The Divisional Superintendent (DS), Pakistan Railways, Multan (the Client) invites sealed bids (Technical & Financial Proposals) from individual/Firms/Companies for the following assignment:

**"PARKING STANDS AND SECURITY ARRANGEMENTS ON RAILWAY
LAND AT RAILWAY STATION MULTAN CANTT".**

1. Sealed Tenders are invited by the Divisional Superintendent, Pakistan Railways, Multan from the Firms / Contractors in connection with aforementioned operation i.e. "PARKING STANDS AND SECURITY ARRANGEMENTS ON RAILWAY LAND AT RAILWAY STATION MULTAN CANTT" as per procedure of Public Procurement Rule-2004 (PPRA-2004).
2. The Firm/Company/Contractor must be a filer.
3. A complete set of Bidding Documents may be purchased by an interested bidder on submission of a written application to the office given below and upon payment of a non-refundable fee of Rs.5,000/-
4. Bidding will be conducted on the basis of Single Stage – Two Envelope procedure.
5. All bidders must be accompanied by a participation fee i.e. "Bid Security @10% of the total cost of accepted financial offer" as participation fee with the Technical Proposal in the form of CDR in favor of Divisional Accounts Officer, Pakistan Railways, Multan (Multan Division) which must be delivered at under mentioned address at or before 12:00 hours on **22-05-2025**.
6. The tender Forms / Bid documents can be purchased from the office of Divisional Commercial Officer, Pakistan Railways, Multan before or upto **22-05-2025 at 11:00 am** during Office hours except Sunday/public holidays.
7. The participation fee and earnest money/Bid security must be attached with Technical Proposals.
8. The participation fee shall be refundable in case of un-successful bidder after deducting 2% processing charges of the paid amount. In case of successful bid, the participation fee shall be adjusted in the offered bid as annual rental against the said assignment.
9. The successful bidder will have to deposit the Performance Guarantee @10% of the total cost of accepted financial offer in the form of CDR in the favour of Divisional Account Officer, Pakistan Railways, Multan Cantt. to be retained by PR till completion or successful termination of agreement.
10. The said contract will be valid for a period of three (03) years and extendable for further period of 02 (two) years subject to satisfactory performance and fulfillment of other codal formalities. The rental charges will be increased by 10% on every successive year amount.
11. Technical Proposals will be opened at 12:30 hours in the office the Divisional Accounts Officer, Pakistan Railways Multan Cantt. on **22-05-2025** in the presence of bidders/representatives who choose to attend. The Financial Proposals will remain unopened and will be held in custody of the Client until the specified time of their opening.
12. Financial Proposals will be opened following the evaluation of Technical Proposals on a date & time which will be conveyed in advance to bidders whose Technical Proposals are declared as technically approved.
13. The parties against whom outstanding, in any shape i.e. rental charges, WHT, electric charges etc. or form exists will not be considered / entertained for the said tender.
