#### 26. SECRECY

The Supplier(s) shall undertake that any information about the sale/purchase of the stores under this contract shall not be communicated to any person, other than the manufacturer of the stores, or to any press or agency not authorized by the DGDP/DP(N) to receive it. Any breach on this account shall be punishable under the Official Secret Act-1923 in addition to termination of the contract at the risk of Supplier. #### 30. INDEMNITY

The Supplier shall at all times indemnify the Purchaser against all claims which the made in respect of the stores for infringement of any rights protected by Paren Registration of besign or Trade Mark and shall take all risks of accidents of the supply from whatever cause arising and the entire responsibility for the sufficiency of all the means used by him for the fulfillmultipated contract provided always that in the event of any claim in respect of alleged breach

#### 31. SUBLETTING

The Supplier shall be entirely respectively for the execution of the contract in all respects according to the terms of the contract. The Supplier shall not subjet, transfer or assign the contract or any part thereof to any other firm/party without prior written permission of the Purchaser.

#### 32. AMENDMENT IN THE CONTRACT

Amendment in the contract, if required, shall be processed in writing by procurement agency upon mutual agreement of both the parties.
