3. This Invitation for Bids is open to all Bidders meeting the following requirements:-

Written request accompanied with attested copies of: -

- a. Pakistan Engineering Council Certificate renewed for the <u>year 2024-25</u> with Category having Specialization Code as mentioned against above must be provided.
- b. The bidder shall be in the active tax payer list (ATL), and will provide income Tax Returns for last three years.
- **C.** The contractors are required to submit their registration for sales tax with Punjab Revenue Authority.
- d. Identity Card of Contractor / Managing Partner / Director of the firm.
- e. Bidding documents will be issued only to the owner / Managing Partner / Director of the firm.
- f. The bidder must have completed at least two contracts of same nature along-with its completion successfully as main contractor **within Ten years**.
