3. Interested bidders intending to participate in the bidding process shall have to deposit Pay order of **Rs.3,000,000/= (Rupees three million only)** as Bid Security (refundable) in favor of Port Qasim Authority issued by a scheduled Pakistani Bank having minimum AA-rating located in Karachi.

4. The sealed bids / offers shall be submitted on 20-05-2025 by **1100 hours** in the office of Manager (Procurement), Stores Department Port Qasim Authority, Karachi. The bids / offers shall be opened on the same day at **1130 hours** at Conference Room of Admin. Building, Port Qasim Authority, Karachi, in the presence of bidders or their authorized representatives, who may wish to attend. The documents received after due date and time will not be entertained. Bids submitted without prescribed Bid Security shall be rejected.

5. Port Qasim Authority reserves the right to accept or reject any or all bids as per PPRA-2004 and no claim whatsoever will be entertained in this regard. Authority's decision in this respect shall be final and binding to all bidders.

TERMS AND CONDITIONS FOR AUCTION OF BER PQA CRAFTS
ON "AS IS WHERE IS" BASIS THROUGH SEALED BIDS

1. The following BER PQA Crafts can be inspected on any working day between 0900 hours to 0400 hours except Saturday and Sunday and other Holidays at Port Qasim one day prior to the closing date. In this regard, further assistance, if any can be requested from Manager (Procurement), Stores Department Port Qasim Authority.
2. The interested bidders shall quote offered rates (lump sum) against each craft as appended below:

3. Details of the above PQA Crafts and terms & condition can be collected from the office of Manager (Procurement) at Stores Department, during office hours Monday to Friday 0900 hours to 0400 hours upon payment of Rs.500/- (non-refundable) in shape of pay order in favor of Port Qasim Authority. The documents of terms & conditions may also be downloaded from PQA/PPRA websites.
4. The prospective bidders interested to participate in the tender shall have to submit sealed bid along with the Pay order of **Rs. 3,000,000/= (Rupees three million only)** as Bid Security (refundable) in favor of Port Qasim Authority issued by a scheduled Pakistani Bank having minimum of AA-rating located in Karachi to the office of Manager (Procurement), Stores Department on or before _____ at 1100 hours. Bids will be opened on the same day at 1130 hours in the Conference Room of Admin Building, Port Qasim Authority, Karachi, in the presence of bidders or their authorized representative, who may wish to attend. The documents received after due date and time will not be entertained. Bids submitted without prescribed Bid Security shall be rejected.
5. In case, if the bids are not opened on the scheduled date, due to unavoidable circumstances the same will be opened on the next date in the presence of committee and bidders. The bids will be received from the bidders signed by the receiving members in sealed condition.
6. The proof of registration with Income tax, SRB and ATL must be enclosed with sealed bids.
7. Bid / offer shall be quoted craft wise (each and every craft separately) in lump sum in Pak Rupees excluding all applicable taxes.

8. All applicable Government Taxes i.e. GST, Income Tax & duties etc. will be required to be paid by the successful bidder at prevalent rates.
 9. Unsuccessful bidder's bid security will be refunded after conclusion/finalization of the proceedings i.e. upon approval of PQA and subsequent accepted by successful bidder(s).
 10. The successful bidder will be allowed to dismantle the crafts at PQA premises as allowed/allocated by the Marine Operation Department within a period of 60 working days
 11. The bidders must satisfy themselves on all the points before bidding, after that no objection or query will be accepted. Subject BER PQA Crafts will be sold on the assumption that the bidders has/have inspected the same and know what they are buying.
 12. Bidders must attach their CNIC copy and contact number along with sealed bid.
 13. Conditional bids/offers shall not be entertained.
 14. All offers / bids shall be valid for 180 days.
 15. The successful bidder will have to pay the full & final cost of the PQA Crafts as approved, inclusive all taxes in shape of pay order in favor of Port Qasim Authority within fifteen (15) working days of issuance of Acceptance Letter. In case of default, acceptance letter will be deemed to be withdrawn and the bid security will be forfeited.
 16. All these PQA Crafts will lie on the spot entirely at the risk of purchaser from the time, the bids are approved till Acceptance letter issued to the successful bidder. However, the BER crafts must be removed/cleared within (60) working days after receipt of full payment. Successful bidder/authorized person will arrange necessary equipment / labor at their own risk and cost for lifting of these PQA Crafts from PQA site. It will also be responsibility of the successful bidder that while removing the craft or its parts, PQA channel or PQA road must not be blocked and same to be cleared by the bidder at the earliest by its own cost.
 17. In case of cutting of the BER crafts the successful bidder shall be responsible for safe operations and shall be liable to pay any damages which may occur due to any lapse on the part of the successful bidder.
 18. Final Lifting Order and Gate Passes for the release of Auctioned items will be issued by Stores Department PQA. Auctioned items will be released on production of receipt showing full payment of bid money.
 19. Port Qasim Authority reserves the right to accept or reject any or all bids / quotation as per PPRA-2004 and no claim what so ever will be entertain in this regard. Authority's decision in this respect shall be final and binding on all bidders.
