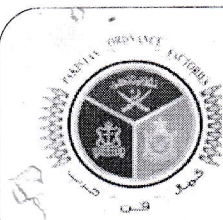

2. The Contractors are required to submit their applications to GM ME POF Sanjwal Cantt upto **13-05-2025** for issuance of tender documents. Contractors who are Active Tax Payers of FBR for income Tax & Sales Tax and duly enlisted with Director Civil Works are eligible to submit their application.

3. For Pre-qualification, parties having experience, capability and resources may apply along with the following information and documents:

i	Partnership deed, article of association or registration of firm's certificate.
ii	Proof of enlistment with other departments.
iii	Certificate regarding financial soundness from scheduled bank.
iv	Proof of experience of list of similar works amounting to more than Rs.10 Million completed during the last 10 years along with names and addresses of clients and copies of work orders.
v	Proof of list of works in hand along with names and address of clients.
Vi	Particular of permanent staff, their qualifications and experience.
Vii	An affidavit that the firm has never been engaged in litigation with any client during last five years.
Viii	An affidavit that the firm has never been black listed by any department.
ix	Certification of payment of income tax and professional taxes.
X	Copy of registration with Pakistan Engineering Council.
xi	Approval from DCW is mandatory.

4. Those who fail to provide above mentioned information/documents (at Sr.No.3) shall be **disqualified**.

5. Contractors already working with POFs only needs to furnish particulars of work in hand outside POFs with the addresses of clients.

The application shall be scrutinized and the tender documents will be issued to the contractors who have sufficient experience in the relevant field and fulfill other special conditions required for job and area. Tender will be issued to the scrutinized contractor's upto **23-05-2025**. Tenders documents should reach the Bid Centre (Library) Welfare Club POF Sanjwal till 10.30 Hrs on **13-06-2025** and opening will be held on **13-06-2025** at 11.00 Hrs.
