Complete Proposals will be received till 11<sup>th</sup> June, 2024 up to 1100 hours (to be dropped in Tender Box available in APM Conference Hall) and will be opened on the same day at 1130 hours in APM Conference Hall, PTB, First Floor, QIAP in presence of intending contractors or their authorized representatives.
- 3. Pre-bid meeting shall be held in APM Conference Hall, PTB, QIAP on 6th June, 2024 at 1100 hours.
