Terms & Conditions:

- Interested bidder must submit an affidavit (on Rs. 50 stamp paper) to the effect that the firm / company has not been blacklisted / defaulter and not involved in any kind of litigation whatsoever with PCAA or any other Govt department / Autonomous body.
- 2. Only those Contactors / Suppliers are eligible to take part in Tender / bidding process who are on Active Taxpayers List (ATL) of FBR.
- 3. Tenders documents which contain details of terms & conditions of the contract, method of execution of works, procedure for submission of Bids etc can be obtained from the office of under-signed during specified time after submission of written request letter along with copies of PEC registration certificate, GST certificate, NTN certificate, Professional Tax Certificate, proof of active taxpayers and deposit of non-refundable Tender fee (i.e. Rs. 500/-).
- 4. Tenders will be issued only to those contractors/ firms who have relevant experience and are registered with Pakistan Engineering Council in the relevant category.
- 5. Earnest Money amounting to Rs. 150,000/- in favor of "Civil Aviation Authority" should be enclosed with the tender documents in shape of pay order/ bank draft from any scheduled bank of Pakistan. Tenders without earnest money will be rejected.
- 6. The tenders will be received up to 1100 hrs on 13-06-2024 and will be opened on the same day at 1130 hrs in the Office of the **Divisional Engineer ES (E&M) Punjab Multan Division, CAA Multan International Airport** in the presence of intending contractors or their representatives.
- 7. No tender will be sold by post or on the date fixed for opening of tenders. Conditional tenders shall not be entertained.
- 8. PCAA reserves all rights to accept or reject any or all the tenders for sufficient / cogent reasons which shall be communicated to the bidders upon request.
- 9. Time period for performance / completion of work shall be **03 months** after issuance of written order to commence.
- 10. <u>Warning:</u> Pay order / Bank drafts or any other financial instrument to be submitted by the bidders / contractors as tender cost, Earnest money / bid security and Bank guarantees if found fake or dishonored by the issuing bank / financial institution at any pre/post contract stage of the case will call for blacklisting and legal action as per law of the land.
