21. <u>Integrity Pact</u>. There shall be "zero tolerance" against bribes, gifts, Understood and inducement of any kind or their promises thereof by Supplier / Firm to any agreed official / staff whether to solicit any undue benefit, favour or otherwise. Following provisions must be clearly read & understood for strict compliance:

a. Integrity Pact shall be applicable to all tenders / contracts irrespective of their financial value. But when such an increase is considered desirable in the interest of expeditious supply of stores and is necessitated by the circumstances beyond the control of the Supplier, the case may be decided accordingly.

## 27. Force Majeure.

a. The supplier will not be held responsible for any delay occurring Understood equipment due to event of Force Majeure such as acts of God, War, Civil agreed not agreed Strike, Lockouts, Act of Foreign Government and its agencies and disturbance unecuy affecting the supplier over which events or circumstances the supplier has n pntrol. In such an event the supplier shall inform the purchaser within 15 days of the happening and within the same timeframe about the discontinuation of such circumstances/happening in writing. Non-availability of raw material for the manufacture of stores, or of export permit for the contracted stores from the country of its origin, shall not constitute Force Majeure.

b. The Supplier shall provide the Purchaser with all the necessary proof of the occurrence of the events and its effect on the contract performance within 30 days from the start to force majeure event.

c. The Purchaser shall be entitled to conduct investigation into the cause of delay reported by the Supplier.

d. Where the delay was due to genuine force majeure event it shall extend the delivery for a period of equal to the period in which such force majeure remains operative.

e. Such extension in delivery period, due to force majeure, shall not entitle the Suppliers to claim any extra from the Purchaser.

28. <u>Arbitration.</u> Parties shall make their attempt to settle all disputes arisin Understood Contract through friendly discussions in good faith. In the event that either party s agreed Contract through friendly discussion to be making insufficient progress towards settlement of Computer (S) at any time, then such party may be written notice to the other party refer the dispute (D) final and biding arbitration as provided below:

a. The dispute will be referred for adjudication to two arbitrators one to be nominated by each party, who before entering upon the reference shall appoint an umpire by mutual agreement, and if they do not agree a judge of the Superior court shall be requested to appoint the umpire. The arbitration proceedings shall be held in Pakistan and under Pakistani Law.

b. The venue of the arbitration shall be the place from which the contract is issued or such other places as the Purchaser at his discretion may determine.

c. The arbitration award shall be firm and final.

d. In course of arbitration the contract shall be continuously be executed except that part which is under arbitration

e. All proceedings under this clause shall be conducted in English language and in writing

29. <u>Court of Jurisdiction</u>. In case of any dispute only court of jul Understood Understood Rawalpindi, Pakistan shall have jurisdiction to decide the matter.

30. <u>Liquidated Damages(LD).</u> Liquidated Damages upto 2% per month Understood Understood be imposed on the suppliers by the purchaser in accordance with DP-35, i agreed supplied after the expiry of the delivery date without any valid reasons. Total value or LD snall not exceed 10% of the contract value.

31. <u>Risk Purchase.</u> In the event of failure on the part of supplier to compared agreed not agreed contractual obligations the contract will be cancelled at the Risk and Expense (ILL) of the supplier in accordance with DP-35.

32. <u>Compensation Breach of Contract.</u> If the contractor fails to digreed understood agreed to default of supplier / seller or stores / equipment declared defective and caused loss to the Government, contractor shall be liable to pay to the Go ment compensation for loss or inconvenience resulting for his default or from the rescission of his contract when such default or rescission take place such compensation will be in excess to the RE amount, if imposed by the competent authority. Compensation amount in terms of money will be decided by the purchase officer and will be deposited by contractor / seller in Government treasury in the currency of contract.

33. <u>**Gratuities/Commission/Gifts**</u>. No commission, rebate, bonus, fee or c Understood understood in any form shall be paid to any local or foreign agent, consultant represen agreed promoter or any intermediary by the Manufacturer/Supplier except the agent commission payable as per the agent commission policy of the government and as amended from to time and given in the contract. (i) To have any part thereof completed and take the delivery thereof at the contract price or.
