The Directorate of Sanitation, Capital Development Authority (CDA) intends to invite bids from the interested and eligible firms / contractors / Suppliers, as per the criteria laid down in bidding document for each work separately in line with Eid-ul-Azha 2024 arrangements, as detailed below:

National Competitive Bidding shall be conducted through Single Stage One Envelope bidding procedure with Least Cost method as stipulated in PPRA Rule 36(a), 2004, as amended from time to time.

Each bid shall comprise one single envelope containing **FINANCIAL PROPOSAL** and **TECHNICAL PROPOSAL** separately. All bids received shall be opened and evaluated in the manner prescribed in the bidding document. Bids in original (signed and stamped) must be in sealed envelope, clearly marked as “**TECHNICAL PROPOSAL & FINANCIAL PROPOSAL**” in bold and legible letters.

Bidding Document, in the English language, shall be purchased from the **Directorate of Sanitation, CDA located at Street # 49, Sector G-6/1-4, Islamabad** till **May 24, 2024** during office hours on any working day against fee of Pak Rs.10,000/- (non-refundable), through pay order or bank draft for each work separately, in favor of Deputy Director Sanitation / DDO Sanitation, CDA.

Bids will be received and opened on **May 27, 2024** at the time mentioned above against each work. The bids will be opened in the presence of bidders / authorized representatives of the bidders to witness the Tender Opening in the office of the **Director Sanitation, CDA located at Street # 49, Sector G-6/1-4, Islamabad**. In case of official holiday on the day of submission, next working day will be treated as closing date. Late Bids shall be rejected.
