Limited. Bids will be opened on the same day at 11:30 A.M in front of bidders or their representative. Pay order of supplier approved by the committee will be retained till completion of supply order. In case of non-compliance of the purchase order, earnest money will be forfeited and purchase order will be treated as cancelled.
- 2. Bids received without earnest money and after due date and time shall not be entertained.
- 3. The competent authority reserves the right to reject any or all the bids in accordance with Rule 33 of Public Procurement Rule 2004.
- 4. Bids provided of each item shall be marked with the price inclusive of all taxes. The purchase order shall be issued independently to the lowest bidder of each item.
- 5. Supply of said items shall be made within two weeks of issuance of purchase order by NESPAK.
