No tender will be accepted after cut down date and time. The bids will be opened on the same date at **1200 hours** in the presence of desirous bidders or their representatives.
- All the proposals and prices shall remain valid **Upto 30 June 2026** for the financial year 2025/2026 from the closing date of the submission of the proposal/ tender.
- All currency in the proposal shall be quoted in Pakistan Rupees (PKR).
- The bidder is hereby informed that the Government shall deduct tax at the rate prescribed under the tax laws of Pakistan, from all payments for services rendered by any vendor who signs a contract with the Government.
- The quoted price should include all the Government taxes.
- The Bidders should clearly indicate the duration of delivery of equipment after the award of contract.
- Only technical details without mentioning the financial aspect of the offer would be enclosed with essential literature / brochure and financial / technical bids will be accepted on depositing of the required samples.
- All publication, catalogues and technical manual will be supplied free of cost by the supplier at the request of HQ Anti Narcotics Force.
- Don't attach any condition with offer / bid and don't represent any firm other than your own.
- All prices may be quoted keeping in view of local market.
- No column to be left blank in the quotations.

- Proposals shall be delivered by hand or courier so as to reach the address given below before closing date and time. **PROPOSAL RECEIVED BY FAX OR EMAIL SHALL NOT BE ACCEPTED.**
- The successful bidder will have to supply the items as per demand and time line given by this office, failing which such bidder shall under embargo for a period, which may be extend upto one year and earnest money will be forfeited in favour of HQ Anti Narcotics Force, Rawalpindi.
- HQ Anti Narcotics Force, Rawalpindi reserves the right to reject all bids or proposal at any time prior to the acceptance of a bid or proposal. The procuring agency shall upon request communicate to any supplier or contractor who submitted a bid or proposal, the ground for its rejection of all bids or proposals, but is not required to justify those grounds.

 - ✓ Complete Bank Statement of last financial year (01 Jul 2024 to 10 Jun 2025)
 - ✓ No Objection Certificate (NOC) from concerned Office/ Institution where firm is working since last two years, that the firm is suitable and there is no case pending with vendor/ contractor.
- HQ Anti Narcotics Force, Rawalpindi will announce the results of bids evaluation in the form of a report giving justification for acceptance or rejection of bids at least ten days prior to the award of procurement contract.
