Tenders without earnest money would not be entertained. Pay Order / Earnest Money of the unsuccessful bidders will be retained till finalization of tender process.
- 5. No tender will be sold by post or on the date fixed for opening of tenders.
- 6. Tenders will be issued only to those Contractors/Firms who will have Professional Tax Clearance Certificate issued by Excise Taxation & Narcotics Control Department.
