

NOTICE FOR INVITING TENDER FOR PROVIDING SECURITY SERVICES AT CAA SKARDU INTERNATIONAL AIRPORT

Pakistan CAA invites tender from renown& licensed security companies/ firms having minimum 10 years relevant experience for providing of security services of CAA protection of Skardu International Airport on 24/7 basis for Two (02) years (extendable) for another Six Months . Major requirements are as under:-

- 2. The interested companies / firms are invited to participate on 02 envelope basis submitting the following details / documents:
 - a) Company / firm profile and history.
 - b) Registration of firm / memorandum and article of association.
 - c) Certificate / undertaking for not having any litigation against CAA. On non judicial stamp paper for appropriate value duly attested by Notary Public.
 - d) Details of permanent employees, experience, number of armed guards, registered with the company are to be provided.
 - e) The armed guards (ex-serviceman) to be deployed, documentary proof with retirement order, pension papers and all relevant information (including latest photograph of each guard is required.
 - f) Refresher training last schedule and frequency.
 - g) A responsible / responsive officer equivalent to the rank of Major / Captain should be nominated as a focal person between CAA and private security guard company.
 - h) Bullet proof Jackets may be provided to 5% to 10% strength of the guards deployed at critical / sensitive location for ensuring the additional security.
 - i) Last 03 years evidence of income tax returns file.
 - j) Valid license of Ministry of Interior and Provincial Govt. to run security agency.
 - k) Registration with income tax authorities, provincial government for sales tax EOBI and ESSI.
 - I) Description of fire arms / weapons with documentary proof of arm license.
 - m) Deposit amount of bid security may be fixed amount not exceeding 5% of the estimated value procurement Successful bidder requires to submit performance guarantee valuing 10% of the contract cost at the time of signing contract (Refundable).
 - n) Last six months bank statement and certificates.

- o) Last year's Audited financial statements.
- p) Certificate of background checks by special branch.
- q) Cliental list with telephone numbers of contact persons.
- r) Quotation is given in consideration of current / latest minimum wages set by Government of Pakistan.
- 2. Contract is for a period of (02) two years (extendable) for another (06) Six months.
- 3. Bid should be dropped in the Tender Box placed at the Reception of COO/APM Skardu Airport on **02**nd **July**, **2024**. The box will be sealed at **1200 hours** and no bid shall be entertained / received thereafter. Tenders shall be opened by the Tender Opening Committee at **1230 hours** on the same day in the presence of bidders / their representatives.
