1. Bid forms/detailed terms & conditions of each shop can be obtained from the office of the Deputy Director Property & Land Pakistan Railways Karachi, Assistant Engineer Pakistan Railway Hyderabad by submitting written request and on an advance payment of a non-refundable participation / bid form fee Rs. 5,000/- for each shop from 10.06.2024 but not later than 30 minutes prior to commencement of the auction, a separate bid form shall be required for each shop.
2. Bid security money amounting to Rs.100,000/- for each shop in shape of Demand Draft/CDR in favour of Divisional Accounts Officer, Pakistan Railways Karachi, (refundable) will be paid by bidder in advance as bid security before start of open auction.
3. Six months rent shall be deposited by the successful bidder in advance in shape of Demand Draft/CDR in favour of Divisional Accounts Officer, Pakistan Railways Karachi.
4. The successful bidder shall be liable to pay 50% of the fixed premium in shape of Demand Draft/CDR in favour of Divisional Accounts Officer, Pakistan Railways Karachi, at the time of auction and 50% at the time of agreement.
