- 2. The Bidders meeting the following requirements will be eligible for participation in the bidding.
 - a. Written request accompanied with attested copies of.
 - b. Pakistan Engineering Council Certificate renewed for the <u>year 2023-24</u> with Category having Specialization Code as mentioned against above must be provided.
 - c. The bidder shall be in the active tax payer list (ATL), and will provide income Tax Returns for last three years.
 - d. The contractors are required to submit their registration for sales tax with Punjab Revenue Authority.
 - e. Identity Card of Contractor / Managing Partner / Director of the firm.
 - f. Bidding documents will be issued only to the owner / Managing Partner / Director of the firm.
 - g. The bidder must have completed at least two contracts of same nature along-with its completion successfully as main contractor within Ten years awarded by <u>WAPDA / NTDC / DISCOs</u>. The consolidated value of these contracts <u>must be more than</u> 40% of the estimated / B.O.Q Cost.
 - h. The contractor will submit separate application for issuance of each tender with relevant documents.
- 3. The bidder should have an **Average Annual Turnover** *half of the amount* mentioned against this work during last three years certified from audited financial statement.
- 4. Bidder shall demonstrate **Cash or Cash Equivalents** *equal to 10% of contract value* and current contract commitments. In this regard bidder shall provide the bank statements of last one year.
- 5. Eligible Bidders may obtain any information regarding bidding, from the Office of **Project Director (GSC) FESCO, Faisalabad up-to 01.07.2024.** A complete set of Bidding

Documents may be purchased by any interested bidder, meeting with the eligibility / qualification criteria, on submission of a written application to the above office and upon payment of a non-refundable fee Rs.2000/- (Two Thousand Rupees) each from the same office.

- 6. All bids must be accompanied by a Bid Security amounting to **5% on BOQ amount** each in favor of **Project Director GSC FESCO Faisalabad** of any scheduled bank of Pakistan and shall be valid 28 days beyond bid validity. The bid shall be valid for 150 Days.
- 7. The bids will be opened at the office of **Project Director GSC FESCO Faisalabad** in the presence of bidder's authorized representatives who choose to attend the tender.
- 8. Tender rates and amounts should be filled in figures as well as in words. Tender documents should be signed as per general directions given in the tender documents.
- 9. All the procurement will be done according to PPRA Rules-2004 amendment up-to 2022.
- 10. Conditional / Electronic Bid shall not be permitted.
- 11. The bids covering partial and incomplete work shall be rejected.
- 12. All the bids along-with relevant documents received without binding with tender book will not acceptable.
- 13. The bidder will submit two copies of his bidding documents i.e. one will be original and 2nd will be photocopy.
- 14. All the pages of tender will be marked as page No. and each page must be signed and stamped by the bidder.
- 15. A certificate will also be submitted with bid documents mentioning that "the tender documents consists of page No.1 to pages.
