Terms & Conditions: -

- a. **Inspection of Vehicles:** The aforesaid vehicles can be inspected during working days (10:00-15:00 hrs.) at the address, PNRA HQs Mauva Area G-8/1, Islamabad. For inspection contact PNRA Transport Branch at 051-9260670 or 0345-5264051. - b. **Venue of Auction:** The venue of auction is PNRA HQs Mauva Area G-8/1, Islamabad.
- c. **Entry into Premises:** - Interested persons are required to bring their valid Computerized National Identity Cards (**In Original**) along with them at the time of auction.
- d. **Sale Price of Vehicle:** - A vehicle will only be sold if highest offer in open auction is more than the reserve prices of the vehicle.
- e. **Time of Auction:** Auction will start on scheduled date and time mentioned above and will continue until the office closing time (16:00 hrs). If not completed, auction will continue on the next day from 10:00 am till completion, office closing time. Auction will continue on next working day in case of Holiday.
- f. **Taxes:** - All admissible Government Taxes will be charged as per prevailing Federal Government Rules in addition to the bid price.
- g. **Participation Fee:** - Participant will have to deposit Rs.10,000/-(refundable) through PO / DD or in cash in the name of Sr. Accounts Officer, PNRA on spot along with copy of CNIC, as Expression of Interest / token money without which no person shall be allowed to participate in the auction.
- h. **Spot Payment:** - Successful / highest bidders shall deposit 25% of the highest bid amount at the spot for each vehicle as Security Money (Non-Refundable), failing which the bid shall be rejected, and security money of the bidder shall be forfeited, and vehicle shall be presented again for auction in future.
- i. **Remaining Amount Payment:** The successful / highest bidder shall have to deposit the remaining bid amount within 15 working days, otherwise, 5% of bid amount shall be charged as ground rent up to the period of next 30 days and thereafter the whole amount will be forfeited.
- j. **Hand Over & Transfer of Vehicles:** The vehicles shall be handed over to the successful / highest bidder after full payment in shape of bank draft / cheque / cash and by depositing taxes in FBR, transfer of ownership from concerned ETO/Motor Registration Authority and cancellation of Government Registration numbers.
- k. PNRA reserves the right to accept or reject any or all bids and to add or withdraw any vehicle at any time before consent of public auction.
- l. In case of any dispute the decision of Auction Committee shall be final and not be challengeable in any court of law.
- m. Employees of the Organization are not allowed to participate in the Auction.
- n. Queries (if any) can be cleared at the spot and thereafter no objection shall be entertained and decision of Auction Committee shall be considered as final.
