Security Companies/Agencies/firms, registered with Income Tax and Sales Tax Department, having National Tax Number (NTN) & on Active Tax Payers List of FBR are eligible to participate in tendering process.

# Terms and Conditions for Bidders under PPRA Rule No.36-C

- Bids are invited for hiring of Security Services under PPRA rule No.36-C "Two stage bidding procedure".
- Bidders, whose technical proposals or bids have not been rejected and who are willing to confirm
  their bids to the revised technical requirements of the procuring agency, shall be invited to submit a
  revised technical proposal along with the financial proposal under PPRA Rule No.36-C (Clause-vi).
- If a bidder withdraws from the bidding process after submission of bid, PTVC reserves the right to forfeit the earnest money.
- Group of companies (joint venture) shall be automatically disqualified from the bidding process.
- The financial bid validity period shall be 120 days from the date of opening of the tender.
- PTV reserves the rights to reject any or all the tenders without assigning any reason in the best interest of PTVC, as per PPRA Rule 33.
- Interested firms/Companies must submit their profile and list of existing clientele.
- Copies of Sales Tax Registration Number and National Tax Number have to be affixed with the bidding documents.
- Details regarding offices operating in Pakistan with addresses & telephone numbers must be provided.
- NOC of company from all provinces including Gilgit Baltistan, AJK & Islamabad Capital Territory is mandatory.
- Employees of Security Company should have group insurance and the company must be registered with EOBI and Social Security Institution etc.
- In case of an emergency the company must have adequate resources available to provide back up at the needed location(s).
- 13. Background verifications of the provided Guards through relevant agencies are mandatory to be provided by the company. "No Black listing Certificate" on original judicial stamp paper (latest) shall be provided to the effect that company has not been involved in litigation or placed on blacklist/debarred by pervious business partner(s).
- 14. The guards should preferably be Armed Forces/paramilitary retired personnel and upper age limit for guards is 50 years with good health.
- 15. Guards must be trained for firefighting/Civil Defense and other security surveillance equipment.
- Detail of weapons in use and valid copies of their licenses have to be provided and all weapons
  possessed by security staff/guards on duty must be duly licensed, with proper tracking ID.

- Any other scientific solution for enhancing security measures would be taken into consideration especially in line with instructions issued by KPID.
- Successful security service provider, whose bid is accepted, will have to sign a legal agreement in light
  of PPRA rule-Clause 16-A(i) i.e for a period of minimum 1 year to maximum 3 years with the
  Corporation.
- Non-compliance to minimum wage rate fixed by the Federal Government/Provincial Government, will lead to disqualification.
- 20. Amount of PKR.5,928,000/- as earnest money shall be applicable on Financial Bids.
- 21. Experience of security services of prominent organizations/Industries will be preferable.
- 22. Eligibility of any company having history of poor performance, shall be subject to the securing marks as mentioned at criteria evaluation grounds portion "C".
- Security Company should have potential to provide communication at all Pakistan, issued by PTA and from the Ministry level (Wireless/Line) will be preferable.
- 24. An evaluation process will be based on the 60/40 principle where 60 marks refer to technical and 40 marks refer to its financial proposal.
- 25. Number of guards can be changed on need basis.
- 26. Annual Working Capital should not be less then Rs. 20 Million.
