## TENDER NOTICE

### GRANT OF LEASE FOR OPERATION, MANAGEMENT AND MAINTENANCE OF FUEL FARMS AT MULTAN INTERNATIONAL AIRPORT & FAISALABAD INTERNATIONAL AIRPORT

1. Civil Aviation Authority (CAA) is inviting tenders on single stage, two envelope basis for grant of lease for Operation, Management and Maintenance of Fuel Farms at Multan International Airport (MIAP) & Faisalabad International Airport (FIAP) for a period of thirty (30) years. All interested OMCs having relevant experience, good reputation and sound financial background are encouraged to participate.
2. Reserve Price for the concession is **Rs. 0.67 per liter** of total Aviation Fuel uplifted at Multan and Faisalabad International Airports, with 5% annual enhancement during subsequent years. Bids higher than the Reserve Price shall be entertained only.

HQCAA Karachi** by **1200 Hours on 7th August 2024**. Technical offers will be opened at **1230 hours** on the same day in presence of the bidders who wish to attend. No tender would be sold on the last day, i.e., day of submission.
