- 2. The Bidders meeting the following requirements will be eligible for participation in the bidding.
 - a. Written request accompanied with attested copies of.

- b. Pakistan Engineering Council Certificate renewed for the <u>year 2024-25</u> with Category having Specialization Code as mentioned against above must be provided.
- c. The bidder shall be in the active tax payer list (ATL), and will provide income Tax Returns for last three years.
- d. The contractors are required to submit their registration for sales tax with Punjab Revenue Authority.
- e. Identity Card of Contractor / Managing Partner / Director of the firm.
- f. Bidding documents will be issued only to the owner / Managing Partner / Director of the firm.
- g. The bidder must have completed at least two contracts of same nature along-with its completion successfully as main contractor within Ten years awarded by <u>WAPDA / NTDC / DISCOs</u>. The consolidated value of these contracts <u>must be more than</u> 40% of the <u>estimated / B.O.Q Cost</u>.
- h. The contractor will submit separate application for issuance of each tender with relevant documents.
- 3. The bidder should have an **Average Annual Turnover** *half of the amount* mentioned against this work during last three years certified from audited financial statement.
- 4. Bidder shall demonstrate **Cash or Cash Equivalents** *equal to 10% of contract value* and current contract commitments. In this regard bidder shall provide the bank statements of last one year.
- 5. Eligible Bidders may obtain any information regarding bidding, from the Office of **Project Director (GSC) FESCO, Faisalabad up-to 15.08.2024.** A complete set of Bidding Documents may be purchased by any interested bidder, meeting with the eligibility / qualification criteria, on submission of a written application to the above office and upon payment of a non-refundable fee for Tender No.777 & 778 **Rs.5000/- (Five Thousand Rupees)** and Tender No.779, 780 & 781 Rs.1000/- each from the same office.
- 6. All bids must be accompanied by a Bid Security amounting to **5% on BOQ amount** each in favor of **Project Director GSC FESCO Faisalabad** of any scheduled bank of Pakistan and shall be valid 28 days beyond bid validity. The bid shall be valid for 150 Days.
