### NOTICE INVITING BIDS

#### FOR MAINTENANCE DREDGING WORKS AT KARACHI PORT

Sealed Bids are invited for Maintenance Dredging Works of Approach Channel, Tipu Sultan Channel and South Wharf Basin for -16m depth at KPT Chart Datum from reputable and experienced dredging firms/companies with proven technical and financial capabilities for executing maintenance dredging of approx. 4.0Mm<sup>3</sup>, through deployment of suitable dredging platform(s) / equipment and allied machinery with discharge/disposal of dredged material at designated dumping site at sea approx. 8 KM from fairway. Anticipated job completion time is 120 days.

The eligible bidders may obtain Bidding Documents from the Office of Project Manager (E), P&D Division, KPT Head Office, Eduljee Dinshaw Road, Karachi on the submission of a written application to the above office and upon payment of a non-refundable fee of Rs. 5,000/- in the form of Pay Order in favour of Chief Account Officer, KPT.

Single stage -Two Envelopes bidding procedure, (Technical & Financial) shall be applied under rule 36(b) of Pakistan Public procurement rules-2004. Initially, only Technical Proposals shall be opened. The Financial Proposals shall be opened after technical evaluation and of only those firms who are declared technically qualified. The date and time for opening of Financial Proposals will be communicated accordingly.

The bidders are required to furnish Bid Security of Rs. 90 million /- (Rs. Ninety Million only) as earnest money with Technical Proposal in shape of pay order in favour of Chief Account Officer, Karachi Port Trust or an un-conditional and irrevocable Bank Guarantee as specified in contract documents, issued by a scheduled Bank having its branch in Karachi and having AA-rating or from a Foreign Bank duly counter guaranteed by a scheduled Bank in Karachi, Pakistan having AA-rating in favour of the Employer valid for, a period of 28 days beyond the Bid validity date.

Tenders will be received at the office of Project Manager (E), KPT on 29-08-2024 by 3:00 PM positively. The technical proposals will be opened on the same day at 3:30 PM in front of the bidders or their representatives who may choose to attend. In the event of changes in the schedules, Karachi Port Trust will notify the same through its website.

A pre-bid meeting shall be held on 07-08-2024 before the submission date, through bidder's personal presence / online.

Karachi Port Trust reserves the right to accept or reject any or all Bids under rule 33 of the Pakistan Public Procurement Rules-2004 and no claim whatsoever in this regard shall be entertained. KPT's decision in this respect shall be final and binding on all firms/companies.
