PAKISTAN CIVIL AVIATION ATUHROTIY (PCAA) invites sealed bids from the interested parties for **the sale of cutting wood/ tree logs in stacks** accumulated through pruning/trimming and removal of dried trees at Civil Aviation Training Institute Hyderabad through open auction on "As is – Where is basis" as per following details:-

- 1. Bids may be submitted as per conditions set out in Auction/Tender documents downloadable from the website www.caapakistan.com.pk or obtainable free of cost from Logistics section CATI Hyderabad on any working day between 0900 Hrs to 1700 Hrs.
- 2. All Bids will be opened publically in presence of the bidders on 27-08-2024 1130 at CATI Hyderabad. No Auction/Tender documents would be issued on the Bid opening date. Last date for issuance of Auction/Tender documents is 26-08-2024. Bids must be dropped in Tender Box placed at under mentioned office by or before due date i.e 27-08-2024 1100 hrs.
- 3. All interested parties may inspect the aforesaid wood stacks along with original CNIC at site two (02) days prior to bid opening date.
- 4. The highest bidder will have to deposit 25% of accepted bid amount on bid opening date while remaining 75% along with the admissible Govt. Taxes plus Rs 1/4th of bid amount as security deposit (refundable) will be deposited within (07) seven days from the date of bid acceptance letter failure to do so shall lead to forfeiture of 25% of bid amount deposited by the bidder without any compensation and next highest bidder shall be awarded the acceptance letter on prescribed terms and conditions.
- 5. The successful bidder is not allowed to sell the stacks before he collects it from the site.
- 6. Competent Authority i.e Director Commercial & Estate shall give the final approval for acceptance of highest bid. The bid acceptance letter shall be awarded after approval from Competent Authority and realization of balance bid amount within specified period.
- 7. Sale shall be made to the bidder offering the highest price subject to approval of competent authority and on receipt of complete payment.
- 8. All auctioned stacks have to be removed and lift from site by successful bidder as per terms and conditions mentioned in the auction/ tender document within 07 days from the date of acceptance letter.
- 9. PCAA reserves the right to accept/reject any or all bids due to cogent reasons which will be communicated to bidders on request.
