ELIGITBILITY

3. This Invitation for Bids is open to all Bidders meeting the following requirements: -

- Written request accompanied with attested copies of: -
- a. Pakistan Engineering Council Certificate renewed for the <u>year 2024-25</u> with Category having Specialization Code as mentioned against above must be provided.
- b. The bidder shall be in the active tax payer list (ATL), and will provide income Tax Returns for last three years.
- **c.** The contractors are required to submit their registration for sales tax with Punjab Revenue Authority.
- d. Identity Card of Contractor / Managing Partner / Director of the firm.
- e. Bidding documents will be issued only to the owner / Managing Partner / Director of the firm.
- f. The bidder must have completed at least two contracts of same nature along-with its completion successfully as main contractor within Ten years awarded by <u>WAPDA / NTDC / DISCOs</u>. The consolidated value of these contracts <u>must be atleast equal to the estimated / B.O.Q (Cost) Amount / Tender amount</u>.
- g. The bidder should have an **Average Annual Turnover** *half of the amount* mentioned against this work during last three years certified from audited financial statement.
- h. Bidder shall demonstrate Cash or Cash Equivalents equal to 20% of contract value and current contract commitments. In this regard bidder shall provide the bank statements of last three months
- Bids will be evaluated by the Evaluation Committee in accordance with the tender conditions in bidding documents & PPRA Rules. Detailed assessment and progress of already awarded contracts and anticipated contracts to each contractor who is participating in the current tender must be carried out.
- j. All safety instructions narrated in NEPRA Safety Code must be adopted in true letter and spirit
- k. The contractor will submit separate application for issuance of each tender with relevant documents.

- 5. A complete set of Bidding Documents may be purchased by any interested bidder, meeting with the eligibility / qualification criteria, on submission of a written application to the above office and upon payment of a non-refundable fee **Rs.3000/- (Three Thousand Rupees).**
- 6. All bids must be accompanied by a Bid Security amounting to **3% on BOQ (Cost) amount** / **Tender Amount** each in favor of **Project Director Construction FESCO Faisalabad** of any scheduled bank of Pakistan and shall be valid 28 days beyond bid validity. The bid shall be valid for 120 Days.
- 7. The bids will be opened at the office of **Project Director (Construction) FESCO Faisalabad** in the presence of bidder's authorized representatives who choose to attend the tender.
- 8. Tender rates and amounts should be filled in figures as well as in words. Tender documents should be signed as per general directions given in the tender documents.
- 9. No rebate on tender rates will be acceptable.
- 10. All the procurement will be done according to PPRA Rules-2004 amendment up-to 2022.

- 11. Conditional / Electronic Bid shall not be permitted.
