Original bids in accordance with the provisions of Rule 36(a) of Public Procurement Rules 2004 and terms & condition defined in the bidding documents must be submitted at the address mentioned below on or before above mentioned date and time.
- The bid security of all bidder will be deposited in CDA bank account and same will be returned after the acceptance of the contract with the successful bidder.**
- The Bids will be opened publically on above mentioned date and time in the presence of Bidder's authorized Representatives who choose to attend the opening session to be held at the office of received in the office of Director Market & Roads Maintenance, CDA, Islamabad.
- In case the total bid amount is less than **10% below** the NIT amount, the bidder shall submit call deposit as performance security equal to the difference between NIT amount and total quoted amount **less 10%** of NIT amount. This call deposit shall be in addition to the earnest money for the work and shall be deposited at the time of submission of bids. Bids not carrying the performance security shall be rejected. The performance security of the successful bidder shall be released after completion of the project.
