Abbasi Shaheed Road, Karachi and will be opened at **11:30 hours** on the same day in the presence of interested bidders, who choose to be present.

- 3) All applicable Govt. taxes shall be deducted, from the payments of the company, as per rules.
- 4) The driver's food and accommodation shall be the responsibility of vehicle supplier for all duties within or outside of Karachi.
- 5) NESPAK reserves the right to accept or reject any/all bids.
- 6) NESPAK will not pay any extra hidden charges. Driver's overtime for local duty within Karachi is to be admissible after 12 hours. The overtime rate should be mentioned separately.
- 7) Sundays / Holidays shall be included in the rent of vehicle on monthly basis.
- 8) The duration of services shall be of One (1) Year which can be extended on satisfactory performance and mutual agreement of both parties.
- 9) The Vehicles should be cleared from CPLC and shall be registered for operation during the period of Contract with registration documentation in the vehicle and registration/number plates affixed to the vehicle as required by law.
- 10) The vehicles shall be compliant with applicable insurance, safety (as to cover any accident liability on passengers and drivers) or other motor vehicle requirements, as may be required by the Client. NESPAK shall not bear any responsibility of Insurance.
- 11) Vehicle shall have tracking facility. Vehicles shall have Excellent mechanical and body condition of vehicles with working AC / HEATER and Seat Belts. The vehicle should be equipped with necessary safety items, spare tire, mechanical jack and basic hand tools. The vehicle should have a well-maintained Log Book. The Supplier should provide timely oil/filter change and mechanical maintenance service as required and provide necessary documents to the Client (NESPAK) as and when required. The vehicle should be cleaned, inside and out and free from any unpleasant odours. The Supplier must ensure the health safety measures to cope with pandemic i.e. COVID-19 etc.
- 12) An Agreement on stamp paper shall be executed with the successful bidder.
