**NOTICE FOR INVITING TENDER FOR PROVIDING SECURITY SERVICES
AT CAA SKARDU INTERNATIONAL AIRPORT**

1. Pakistan Airports Authority (PAA) invites tender from renown & licensed security companies / firms having minimum 10 years relevant experience for providing of security services of Skardu International Airport on 24/7 basis for Two (02) years (extendable) for another Six Months Major requirements are as under : -

Trained Armed Guards:	<ul style="list-style-type: none">❖ 10❖ Age should not be over 55 years.❖ Height 5'-6", Able Body/medically fit.❖ Education (minimum middle, preferably Matric).

2. The interested companies / firms are invited to participate on 02 envelope basis submitting the following details / documents:-

- a) Company / firm profile and history.
- b) Registration of firm / memorandum and article of association.
- c) The bidder shall furnish undertaking on non-judicial stamp paper of value of rupees 100/- to the effect that it has not been black listed by any government, semi government and autonomous body.
- d) Minimum number of clients of the bidder for providing similar services shall be 03.
- e) The armed guards (ex-serviceman) to be deployed, documentary proof with retirement order, pension papers and all relevant information (including latest photograph) of each guard is required.
- f) The bidder must have minimum 03 years work experience of the similar services.
- g) A responsible / responsive officer equivalent to the rank of Major / Captain should be nominated as a focal person between PAA and private security guard company.
- h) The bidder has valid NTN certificate.
- i) Valid license of Ministry of Interior and Provincial Govt. to run security agency.
- j) The bidder shall be registered with social security and EOBI.
- k) Description of fire arms / weapons with documentary proof of arm license.
- l) The intending firms has to furnish a bid security of rupees 196,032/- at the time of submission of bids. The security fees will be returned to technically un-successful bidder along-with its financial proposal.
- m) Security deposit of the technically successful bidders and un-successful in financial bid will be returned upon award of contract to successful bidder or on expiry of bid validity.
- n) Security deposit of financially successful bidder will be returned on furnishing performance bound 5% of the total contract value.

- o) The bidder shall provide last six months bank statement from schedule banks.
- p) The bidder shall provide Certificate / undertaking that they can provide to PAA all such information data, documentation, accounting records etc. pertaining to their operations etc. within 7 days of the request for the same.
- q) The bidder shall give an undertaking on non-judicial stamp paper of value of rupees 100/- that it will pay all the regulatory dues, taxes etc. and will abide by the minimum wage rate determine by the government.
- r) The bidder shall disclose details of its litigations subjudice before any court of law by or against any of its clients including PAA if any.
- s) Last 03 years' Audited financial statements.

2. Contract is for a period of (02) two years (extendable) for another (06) Six months.

3. Bid should be dropped in the Tender Box placed at the Reception of COO/APM Skardu Airport on **23th October, 2024**. The box will be sealed at **1200 hours** and no bid shall be entertained / received thereafter. Tenders shall be opened by the Tender Opening Committee at **1230 hours** on the same day in the presence of bidders / their representatives.

5. PAA defaulters and bad reputed companies shall not be entertained.

6. PAA reserves the rights to reject all bids or proposals at any time prior to acceptance of a bid or proposal. PAA upon request shall communicate to any security agency which submitted bid or proposal, the grounds of rejection of all bids or proposals but is not required to justify these grounds.

7. Tender Forms (RFP) can be purchased at the cost of Rs 2000/- by depositing Pay Order/ Bank Draft in favor of COO/ APM Skardu International Airport.
