Bidders must submit their bids along with scanned copy of the bid security in shape of CDR or Bank Guarantee through E-Pak Acquisition & Disposal system (E-PADS). The bids prepared in accordance with the instructions in the bidding documents, must be uploaded on EPADS after being scanned besides enclosed in sealed envelope accompanied with copies of the CNIC, valid license of registration with Pakistan Railway, present ATL status of the bidder & original bid security in shape of Call deposit (CDR) or Bank Guarantee in favour of Divisional Accounts Officer Pakistan Railways Rawalpindi are required to be dropped in tender box in the office of Divisional Accounts Officer, Pakistan Railways Rawalpindi upto 25.09.2024 till 13:30 hours.

Only bids through EPADS will be entertained and no other bid will be accepted except EPAD. Bids will be opened on same date and venue at 14:00 hours in the office of the Divisional Accounts Officer, Pakistan Railways Rawalpindi in the presence of the representatives of the firms who want to be witness.

The Railway administration may reject all bids at any time prior to the acceptance of a bid. The Railway administration shall upon request communicate to any contractor who submitted a bid, the ground for its rejection of all bids.
