

INVITATION FOR BIDS

1. FESCO INTENDS TO INVITE BIDDERS FOR THE FOLLOWING TENDER: -

Bidding is open to all eligible firms who are pre-qualified / registered with DISCOS / NTDC / WAPDA.

2. FESCO invites sealed bids on **percentage basis (Above / below) on estimated amount**, under Single Stage-Single Envelope bidding procedure, from eligible firms under **National Competitive Bidding (NCB)** basis in accordance with Provisions of PPRA Rules.

ELIGIBILITY

3. This Invitation for Bids is open to all Bidders meeting the following requirements:-

Written request accompanied with attested copies of: -

- Pakistan Engineering Council Certificate renewed for the **year 2024-25** with Category having Specialization Code as mentioned against above must be provided.
- The bidder shall be in the active tax payer list (ATL), and will provide** income Tax Returns for last three years.
- The contractors are required to submit their registration for sales tax with Punjab Revenue Authority.
- Identity Card of Contractor / Managing Partner / Director of the firm.
- Bidding documents will be issued only to the owner / Managing Partner / Director of the firm.
- The bidder must have completed at least two contracts of same nature along-with its completion successfully as main contractor **within Ten years awarded by WAPDA / NTDC / DISCO's**.
- The consolidated value of these contracts **must be more than** 40% of the **estimated / B.O.Q Cost**.
- The bidder should have an **Average Annual Turnover two times of the amount** mentioned against this work during last three years certified from audited financial statement.
- Bidder shall demonstrate **Cash or Cash Equivalents equal to 20% of contract value** and current contract commitments. In this regard bidder shall provide the bank statements of last one (01) year.

- j. Bids will be evaluated by the Evaluation Committee in accordance with the tender conditions in bidding documents & PPRA Rules. Detailed assessment and progress of already awarded contracts and anticipated contracts to each contractor who is participating in the current tender must be carried out.
 - k. All safety instructions narrated in NEPRA Safety Code must be adopted in true letter and spirit
 - l. The contractor will submit separate application for issuance of each tender with relevant documents.
4. Eligible Bidders may obtain further information, inspect and acquire the Bidding Documents from the Office of **Superintending Engineer (Civil) FESCO, Faisalabad up-to 01-10-2024.**
 5. A complete set of Bidding Documents may be purchased by any interested bidder, meeting with the eligibility / qualification criteria, on submission of a written application to the above office and upon payment of a non-refundable fee **Rs. 3000/- (Three Thousand Rupees) each tender.**
 6. All bids must be accompanied by a Bid Security amounting to **5% on BOQ amount** each in favor of **Executive Engineer (Civil) Civil Works Division-II FESCO Faisalabad** of any scheduled bank of Pakistan and shall be valid 28 days beyond bid validity. The bid shall be valid for 150 Days.
 7. The bids will be opened at the office of **Superintending Engineer (Civil) FESCO, Faisalabad** in the presence of bidders / bidder's authorized representatives who choose to attend the tender.
 8. Tender documents should be signed as per general directions given in the tender documents.
 9. No rebate on tender rates will be acceptable.
 10. All the procurement will be done according to PPRA Rules-2004 amendment up-to 2022.
 11. Conditional / Electronic Bid shall not be permitted.
 12. The bids covering partial and incomplete work shall be rejected.

Note: - FESCO reserves all its rights regarding rejection of tenders without providing any justification as defined in Clause-33(1) of PPRA Rules-2004 amendment up-to 2022.
