Tender documents are to be dropped in the Box placed in the **Main Conference Room (Room No.6035) at Level-VI, Jinnah Terminal, JIAP Karachi** by the specified date and time. The Box will be sealed and no tender documents would be allowed after the specified time. Technical offers would be opened after half an hour after sealing the Box in the presence of the bidders who wish to attend. No tender would be sold on the last day i.e., day of submission.

5. Advance Income Tax will be recovered from the successful bidder/ licensee under Section 236-A of Income Tax Ordinance 2001. Defaulter of CAA dues are not eligible to apply. Late, ambiguous and / or conditional tender shall not be entertained.

If a bidder submits fake/bogus pay orders as Earnest Money or any other fake / tempered document, not only the company / firm / individuals' tender will be cancelled and the company / firm / individual will be debarred / blacklisted, but its security deposit / Earnest money etc. will also be forfeited.

If a sitting licensee or any of its associated firm/ companies/ sole proprietors participating in the tender has outstanding CAA dues as per billing record of CAA at any of CAA Airport/ location, on the date of tender opening, its bid(s) will stand technically disqualified. However, outstanding dues of current month will not disqualify such sitting licensee.
